LEGAL NOTICE NO. 104 OF 2012

THE COMMISSIONER OF OATHS ACT, 1942  
(Act No. 23 of 1942)

THE COMMISSIONER OF OATHS (AMENDMENT OF PART II  
OF THE SCHEDULE) NOTICE, 2012  
(Under Section 3)

In exercise of the powers conferred by Section 3 of the Commissioner of Oaths Act, 1942, the Minister for Justice and Constitutional Affairs amends Part II of the ex-officio Commissioners of Oaths Schedule as follows -

***Citation and Commencement***

1. (1) This Notice may be cited as the Commissioner of Oaths (Amendment of Part II of the Schedule) Notice, 2012.

(2) This Notice shall come into force on the date of publication in the gazette.

***Amendment of the Second Schedule***

2. The Second Schedule is amended by inserting the following offices in alphabetical sequence -

*Vacation of office*

5. (1) The Chairperson and other members shall vacate office and the office of the Chairperson or member shall be vacated if the Chairperson or member -

- (a) is declared bankrupt;
- (b) is absent from three executive meetings without justifiable cause;
- (c) becomes mentally or physically incapable of performing the duties assigned to the office of the Chairperson or that member; or
- (d) resigns from office;

(2) The Minister may remove the Chairperson or member from office for gross misconduct by the Chairperson or member.

*Existing Committees, etc.*

6. Any existing committee, Bandlancane, council or development committee shall cease to exist.

*Allowances*

7. The Chairperson and other members shall be entitled to such allowances and where applicable, reimbursement of travelling expenses as determined by the Minister.

(Order No. 25 of 1973)THE MAXIMUM WHOLESALE AND RETAIL PRICES OF  
PETROLEUM PRODUCTS NOTICE, 2012  
(Under Section 5 and 10)

In exercise of the powers conferred by Section 5 and 10 of the Price Control Order, 1973 the Price Controller issues the following Notice.

**Citation and Commencement**

1. This Notice may be cited as the Maximum Wholesale and Retail Prices of Petroleum Products Notice, Wednesday 4<sup>th</sup> July 2012 and shall be deemed to have come into force at midnight on the 4<sup>th</sup> July 2012.

**Maximum Prices and Petroleum Products**

2. (1) Subject to Section 2 (2), the Maximum Wholesale and Retail Prices of Petroleum Products shall be as set out in the Schedule to this Notice.

(2) Maximum Wholesale and Retail Prices of Petroleum Products as set out in the Schedule shall be subject to the condition that no oil company shall grant or allow a rebate or discount to any customer without first obtaining the consent of the Price Controller.
