SWAZILAND TOURISM AUTHORITY ACT, 2001
(Act No. 2 of 2001)

LEVIES PAYABLE BY ACCOMMODATION ESTABLISHMENTS
REGULATIONS, 2012
(Under Section 27)

In exercise of the powers conferred by Section 27 of the Swaziland Tourism Authority Act, 2001 the Minister for Tourism and Environmental Affairs issues the following Regulations -

Citation and Commencement

1. (1) These Regulations may be cited as the Levies Payable By Accommodation Establishments Regulations, 2012.

(2) These Regulations shall come into force on the date of publication in the gazette.

Tourism levy

2. An owner of an accommodation establishment, other than a campsite or camping and caravan park owner shall pay a levy to the Authority as prescribed these Regulations.

Basis for Calculating the Levy

3. The levy payable shall be Seven Emalangeni Fifty Cents per each bed used per night.

Payment of Levy

4. (1) The levy shall be paid every month calculated with effect from -

(a) the date of commencement of these Regulations; or

(b) the date of registration of a new establishment after the commencement of these Regulations.

(2) The levy shall be paid to the Authority -

(a) not later than the last day of the calendar month that follow a levy period; or

(b) if the last day of the month falls on a Saturday, Sunday or public holiday on the first business day after that day.

(3) The levy shall be paid to the Authority or to any agent which the Authority has approved.

(4) The levy shall be accompanied by a statement reflecting the period for which that levy is being paid for.

Late Payment of Levy

5. The owner or person in charge of an accommodation establishment who fails to pay the prescribed levy on the required date, shall in addition to the levy pay an extra five percent of the outstanding amount in respect of each month or a part of a month during which the outstanding amount remains.

Access to Financial Records

6. The Authority shall on request have access to financial records of any establishment to verify the authenticity of the declared information regarding the levy.

Offences and Penalties

7. The owner or person in charge of an accommodation establishment who -

- (a) on expiry of fourteen days after the Authority has sent a written demand requesting payment of any outstanding levy or of interest accrued;
- (b) under declares the number of beds used during the levy period;
- (c) obstructs or refuses the Authority access to its financial records;

commits an offence and shall on conviction be liable to a fine not exceeding Five Thousand Emalangenani or to a sentence of imprisonment not exceeding one year or to both.
