## THE APPROPRIATION ACT, 2014

(Act No. 01 of 2014)

AN ACT  
ENTITLED

**AN ACT** to provide for the appropriation of a certain sum of money "for the financial year commencing on the 1<sup>st</sup> April, 2014 and ending 31<sup>st</sup> March, 2015.

**ENACTED** by the King and the Parliament of Swaziland.

*Short title and commencement*

- (1) This Act may be cited as the Appropriation Act, 2014.
- (2) This Act shall be deemed to have come into force on the 1<sup>st</sup> April, 2014.

*Charge to Consolidated Fund*

2. The Consolidated Fund is charged with a sum of money not exceeding in the aggregate Fourteen Billion, Three Hundred and Sixty Nine Million, and Two Hundred and Thirty Seven Thousand Emalangeni (14,369,237,000) as required for the services of the Government of the Kingdom of Swaziland during the financial year commencing on the 1<sup>st</sup> April, 2014 and ending on the 31<sup>st</sup> March, 2015.

*Application of sum appropriated*

3. The sum appropriated under section 2 shall be applied to the services set out in the second column of the Schedule and in the respective amounts appearing in the third and fourth columns in respect of each service.

ENTITLED

AN ACT to provide for the supplementary appropriation of a certain sum of money for the financial year ending 31<sup>st</sup> March, 2014.

ENACTED by the King and the Parliament of Swaziland.

*Short title and commencement*

1. (1) This Act may be cited as the Supplementary Appropriation Act, 2014.
- (2) This Act shall come into force on the date of publication.

*Charge to Consolidated Fund*

2. The Consolidated Fund is charged with the sum of money not exceeding in the aggregate Three Hundred and Eighteen Million, Thirty-Nine Thousand and Fifty Seven Hundred Emalangeni for additional requirements for the services of the Government of the Kingdom of Swaziland during the financial year ending on the 31<sup>st</sup> March, 2015.

*Application of sum appropriated*

3. The sum appropriated under section 2 shall be applied to the services set out in the second column of the Schedule and in the respective amounts appearing in the third and fourth columns in respect of each service.
