POWER OF ATTORNEY

A power of Attorney created this 2nd Day of October, 1999 by me BENJAMIN WILLIAM MKAPA, President of the United Republic of Tanzania.

Whereas I am desirous to provide for the due and proper execution of mortgage deeds and charges in respect of lands, tenements and hereditaments mortgage and charged to secure the repayments of loans made from Urban Housing Loans scheme and for the release, acquittance and discharge of the same and for such other matters relating thereto and incidental herewith as hereinafter appears.

AND WHEREAS I have by deedbearing the date hereof, but executed before these presents revoked all former powers of Attorney in that behalf.

Now, this deed witnesseth that, I BENJAMIN WILLIAM MKAPA, hereby appoint THADDEUS SIMON MWAKILEMA of the Ministry of Lands, and Human Settlements Development, Dar es Salaam (hereinafter called the Attorney) to be my lawful Attorney from the date hereof, for me, in my name and for my benefit to perform the following acts, that is to say:-

(1) To accept lands, tenements and hereditaments mortgage or charges to secure the repayment of loans made from Urban Housing Loan scheme upon first legal mortgage and charges, and to sign, execute and deliver as my act and deed and made perfect such mortgage deeds and charges in respect thereof as contain terms, conditions and covenants not less favourable to me than those set forth in the schedule hereto, and to do all things on my behalf which may be necessary for completing such mortgage and charges including all such applications, notifications and registration for the purposes of the Registration Ordinance (Cap. 334) or any Ordinance or repealling the same for the purpose of any other ordinance or law as may be necessary.

(2) To receive every sum of money whatsoever which now is or hereafter becomes due arising or belonging to me upon or by virtue of any such mortgage or charge and on receipt thereof to sign, execute, make and give good and sufficient releases, acquittances or other discharges for the same, and also to sign, execute, make and deliver as my act and deed all proper and sufficient reconveyances, releases and other assurances of the lands, tenements and hereditaments which shall have been mortgaged or charged as security as aforesaid.

(3) To consent to any alteration or modification of the terms conditions or covenants of any such security and to

sign, execute and deliver as my act and deed and make perfect any deed, agreement, contract, instrument, surrender or assurance for such purpose and to do all things necessary on my behalf for the completing registering and recording the same;

Provided, however, that no such alteration or modification shall be made by which the terms, conditions or covenants of or contained in any such security as altered or modified shall be less favourable than those set out in the schedule hereto.

AND I, BENJAMIN WILLIAM MKAPA, hereby declare that all and every such execution, deed, charge, release, conveyance, assurance, discharges, acquittance, agreement, contract, instrument or surrender which will be given, made or done by the Attorney shall be as good, valid and delivered, given or made or done by me as my act and deed in my own proper person and I hereby undertake to ratify and confirm whatever the Attorney shall do or purport to do by virtue of this Power of Attorney.

THE SCHEDULE

Terms and conditions or mortgages and charges which the Attorney is entitled to execute under the provisions of this power:-

1. Covenants by the Borrower/Mortgagor:-

- (a) To repay the Principal sum advanced with interest at a rate not less than four and one quarter per centum per annum within not more 20 years.
- (b) To repay any sum expended by the lender by way or premium in insuring for not less than the principal sum advanced, the property mortgaged or charges.
- (c) To repay all sums paid by the lender/mortgagee in the exercise of his powers under the provisions of subparagraphs (a) and (b) or paragraph 2 hereof.
- (d) To observe and perform the conditions and covenants of the right of occupancy or lease (as the case may be) under and by virtue of which the Borrower/Mortgagor holds the property mortgaged or charged.
- (e) To observe and perform all covenants touching and bidding the property mortgaged or charged.
- (f) to allow the lender/Mortgagee, his servants and agents to inspect the premises at all times
- (g) To deliver up the title deeds of the property Mortgaged or charged.

2. Power to the Lender/Mortgagee:-

- (a) To enter upon the property mortgaged on charged and executed and perform the conditions as to development contained in any right of occupancy over the property mortgaged or charged in the event of the Borrower/Mortgagor failing to do so;
- (b) To enter into possession of the property mortgaged or charged if the Borrower/mortgagor fails to observe the covenants on his part contained in the mortgage deed or charge for a space of three months or if he becomes bankrupt and to demolish and sell any dwelling house or other building or structure thereon and to sell any building or other materials thereon;
- (c) To exercise the power of sale and of appointing a receiver conferred on lender in a mortgage by deed by the (Imperial) conveyancing and law of property Act, 1881, in any case in which he has power to enter upon the property mortgaged or charged, in the exercise of the power hereinbefore contained.

(2) To receive every sum of money whatsoever which now is or hereafter becomes due arising or belonging to me upon or by virtue of any such mortgage or charge and on receipt thereof to sign, execute, make and give good and sufficient releases, acquittances or other discharges for the same, and also to sign, execute, make and deliver as my act and deed all proper and sufficient recoveries, releases and other assurances of the lands, tenements and hereditaments which shall have been mortgaged or charged as security as aforesaid.

(3) To consent to any alteration or modification of the terms conditions or covenants of any such security and to sign, execute and deliver as my act and deed and make perfect any deed, agreement, contract, instrument, surrender or assurance for such purpose and to do all things necessary on my behalf for the completing registering and recording the same;

Provided, however, that no such alteration or modification shall be made by which the terms, conditions or covenants of or contained in any such security as altered or modified shall be less favourable than those set out in the schedule hereto.
