NOTICE IS HEREBY GIVEN that by virtue of the powers conferred upon the Commissioner for the Constituent Assembly by paragraph (d) of sub-section (1) of section 22 of the Constituent Assembly Statute, No. 6 of 1993, and by sub-rule (1) of rule 6 and sub-rule (1) of rule 3, of the Constituent Assembly Election Rules (Third Schedule to the Statute):

(a) every person whose name appears in the first column of the Schedule to this Notice is hereby appointed Returning Officer, for the purposes of the Constituent Assembly elections, for the respective district appearing in the third column against each name;

(b) the power vested in the Commissioner by sub-rule (1) of rule (3) to appoint registration officers, for the purpose of compiling a voter's register for each Electoral Area, is hereby delegated to each Returning Officer. Each Returning Officer is to appoint three registration officers for each parish;

(c) each Returning Officer shall be the overall registration officer in relation to the registration of voters within each Electoral Area of the district to which the person is returning officer.
