## THE CONSTITUENT ASSEMBLY STATUTE, 1993.

### BY-ELECTION—MBALE MUNICIPALITY ELECTORAL AREA.

#### DECLARATION OF NOMINATION DAYS.

(Under section 28 of the Statute and rule 7 of the  
Constituent Assembly Election Rules).

#### NOTICE.

WHEREAS the Chief Magistrate's Court sitting at Mbale on the 8th day of July, 1994, nullified the election of the delegate to the Constituent Assembly for Mbale Municipality Electoral Area:

AND WHEREAS the Minister of State for Constitutional Affairs has, on Monday, 8th August, 1994, issued a Writ requiring the Commissioner for the Constituent Assembly to take appropriate steps for a by-election to take place in Mbale Municipality Electoral Area not later than the 31st of August, 1994:

#### NOW THEREFORE:

1. In accordance with sub-rule (1) of rule 7 of the Constituent Assembly Statute, 1993, I declare Monday 15th and Tuesday 16th August, 1994, Nomination Days for candidates for the by-election to take place in Mbale Municipality Electoral Area.

2. Every person aspiring to be a candidate for the by-election shall tender his or her nomination paper to the Returning Officer on any of those two days between the hours of 10.00 a.m. and 4.00 p.m.

3. The place where the nomination of candidates shall take place is the office of the Returning Officer, Mbale District, Mr. Charles Kabunga, who is the DES for Mbale District.

4. Every person wishing to be nominated as a candidate,

(a) shall submit to the Returning Officer a Nomination Paper in Form NP which may be collected from the office of the Returning Officer before Nomination Days; and

(b) shall submit to the Returning Officer a copy of Form DQ (Declaration of Qualifications) duly sworn before a Commissioner for Oaths. Form DQ may also be collected from the office of the Returning Officer, Mbale, before nomination days.

5. The nomination of every candidate,

(a) shall be proposed by two registered voters of Mbale Municipality Electoral Area and who normally reside in that Electoral Area;

(b) shall be supported by ten registered voters of Mbale Municipality Electoral Area and who normally reside in that Electoral Area;

(c) shall be accompanied by a fee of one hundred thousand shillings payable in cash or bankdraft to Uganda Administration; and

(d) shall be accompanied by three passport size photographs of the person seeking nomination. The picture of each aspiring candidate shall be taken by the Returning Officer immediately prior to the nomination process.

6. The Returning Officer shall design a programme of Candidates' Meetings, so that one Candidates' Meeting takes place in each of the eleven parishes of Mbale Municipality between Saturday 20th August, 1994, and Sunday 28th August, 1994.

BY-ELECTION—MBALE MUNICIPALITY  
ELECTORAL AREA

APPOINTMENT OF POLLING DAY.

(Under section 28 of the Statute and rule 14 (1)  
of the Constituent Assembly Election Rules).

NOTICE.

IN EXERCISE of the powers conferred upon the Commissioner for the Constituent Assembly by sub-rule (1) of rule 14 of the Constituent Assembly Election Rules (Third Schedule to the Statute) Monday 29th August, 1994, is hereby appointed Polling Day for the by-election to take place in Mbale Municipality Electoral Area.

1. On polling day,

(a) polling shall commence, at all polling stations, within Mbale Municipality Electoral Area, at 7.00 a.m. in the morning and close at 5.00 p.m. in the afternoon;

(b) in accordance with rule 20 of the Constituent Assembly Election Rules, every voter who is unable to mark the ballot paper with a mark of choice shall bring with him or her, to the polling station, either a spouse or any member of the voter's family to mark the ballot paper on behalf of the voter, a Presiding Officer or a Polling Assistant may assist the voter to mark the ballot paper only where the voter requests the Presiding Officer or Polling Assistant to do so.

2. Only voters whose names appear in the register of voters shall be eligible to vote in the by-election.

3. In order to enable the registered voters to understand who is eligible to vote and the location of the polling stations where they will cast their votes on polling day, the Returning Officer shall, by Monday 15th August, 1994, circulate to every RC I Chairman within Mbale Municipality Electoral Area, a copy of the register of voters within the respective RC I Area, and every RC I Chairman shall be required to immediately display the register in a conspicuous place within the RC I area. The Returning Officer shall also avail similar copies of the register to every RC II Chairman of the area.

4. In order to obtain a ballot paper on polling day, each voter shall present his or her certificate of registration to the Presiding Officer. Where a voter, whose names appear in the register of voters has lost his or her certificate of registration, he or she may approach the RC I Chairman of the area, who, if satisfied that the voter is genuine, may write a

certification of identity to be signed by the Chairman himself and four other members of the RC I Committee and such certification may serve as the certificate of registration to enable the voter obtain a ballot paper. However, such certification shall be retained by the Presiding Officer and sealed in the ballot box at the closure of the poll.
