IN EXERCISE of the powers conferred upon the Minister by section 5A of the External Trade Act, this Order is made this 9th day of July, 2001. Cap. 103.

1. This Order may be cited as the External Trade (Importation Licence) (No. 10) Order, 2001. Citation.

2. (1) The persons listed in column 1 of the Schedule are granted exclusive licences to import used tyres of different sizes, in the quantities listed in column 2 of the Schedule. Grant of exclusive licence.
