Electoral Commission (Amendment) (No. 2) Act

THE ELECTORAL COMMISSION (AMENDMENT) (NO. 2) ACT, 2002.

An Act to amend the Electoral Commission Act, 1997.

DATE OF ASSENT: 18TH NOVEMBER, 2002.

Date of commencement: 1st October, 2002.

BE IT ENACTED by Parliament as follows:

1. This Act may be cited as the Electoral Commission mendment) (No. 2) Act, 2002 and shall be deemed to have come into force on the 1st day of October, 2002.

Short title and commencement.

2. For the purposes of the by-election to be held as a result of the vacancy that occurred in the Rubanda East Constituency in October, 2002 in the membership of Parliament, subsection (1) of section 25 of the Electoral Commission Act, 1997 shall have effect as if for the period of not less than twenty one days prescribed for the display of a copy of the voter's roll, there were substituted a period of not less than ten days.

IN EXERCISE of the powers conferred upon the Chief Fisheries Officer by section 3 of the Fish Act, this Instrument is Cap. 228. made this 13th day of August, 2002.

- 1. This Instrument may be cited as the Fish (Immature Fish) Instrument, 2002.
- 2. For the purposes of the Act, in the waters set out in column 1 of the Schedule to this Instrument, the species of fish specified in column 2 of the Schedule shall be immature if of a length less than that specified in column 3 to the Schedule.
- 3. The Fish and Crocodiles (Immature Fish) Instrument, 1981, is revoked.
