ON THE MATTER OF THE COMPLETION OF THE DIVESTITURE OF UGANDA ELECTRICITY GENERATION COMPANY LTD. (UEGCL)

NOTICE

Under Clause 12(5) of the Privatisation Guidelines, Second Schedule of the Public Enterprises Reform and Divestiture Act Cap. 98 Laws of Uganda 2000) the Utility Reform Unit of the Ministry of Finance, Planning and Economic Development of the Republic of Uganda hereby notifies the general public that the Divestiture of the public enterprise known as Uganda Electricity Generation Company Limited (UEGCL) was completed on the 26th day of November 2002 by signing a Concession and Assignment Agreement relating to the Nalubale and Kiira Hydroelectric Power Stations located near Jinja, Uganda.

The Divestiture was implemented as follows:

- o The Divestiture and Reform Implementation Committee in its 290th meeting held on the 1st day of November, 2002 agreed that the Uganda Electricity Generation Company Ltd. be concessioned to Eskom Enterprises Africa (EEA) for a 20 year concession after public tendering. - o The successful bidder was Eskom Enterprises Africa, Megawatt Park, Maxwell Drive, Sunninghill, Sandton, P. O. Box 1091, Johannesburg 2000, South Africa.
- o The Divestiture and Reform Implementation Committee accepted an offer of US \$500,000 being the transaction fee and additional payments of Monthly concession fee deduced as follows:
 - o UEGCL's existing debt obligations
 - o Depreciation of UEGCL's assets
 - o Interest on any new debt raised by UEGCL to fund the investment program, and
 - o UEGCL's administrative costs.
- EEA's bid was evaluated on the basis of its proposed Generation Operational and Maintenance Charge (GOMC) for the first seven (7) years of the Concession, thereafter subject to review for the remaining period of the Concession, as well as its proposed rate of return on all investments the company makes. Here below is EEA's GOMC as presented to and accepted by GOU:


