



**The Amnesty Act (Extension of Expiry Period) (No. 3)
Instrument, 2004.**

IN EXERCISE of the powers conferred upon the Minister by section 16 of the Amnesty Act, this Instrument is made this 14th day of May, 2004.

1. (1) This Instrument may be cited as the Amnesty Act (Extension of Expiry Period) (No. 3) Instrument, 2004.

Citation and commencement.

(2) This Instrument shall come into force on the 17th day of May, 2004.

2. The expiry period of the Amnesty Act is extended for a period of three months.
