

Completion of Update of Voters' Register in Pader District)
Instrument, 2004.**

*Under section 19 (7) and (8)(a) of the Electoral Commission Act,
Cap 140 (as amended).*

IN EXERCISE of the powers conferred upon the Commission by section 19 (7) and (8)(a) of the Electoral Commission Act, 1997 (as amended), this Instrument is made this 30th day of July, 2004.

1. This Instrument may be cited as the Electoral Commission (Appointment of Date of Completion of Update of Voters' Register in Pader District) Instrument, 2004.

2. The 2nd day of August, 2004 is hereby appointed as the date upon which the Commission shall complete the exercise of updating the Voters' Register for purposes of the Local Government council election/by-election in Pader District.

3. For purposes of paragraph 2 of this Instrument, after the appointed date no application form in Pader District shall be accepted by the Electoral Commission, seeking—

- (a) to register as a voter; or
- (b) to transfer to a new voting location.
