**The Magistrates' Courts (Magisterial Areas) (Amendment) Instrument, 2004.**

*(Under sections 1 and 2 of the Magistrates' Courts Act, 1970  
No. 13 of 1970).*

IN EXERCISE of the powers conferred upon the Minister by sections 1 and 2 of the Magistrates' Courts Act, 1970, and after consultation with the Chief Justice, this Instrument is made this 8th day of July, 2003.

**1. Citation**

This Instrument may be cited as the Magistrates' Courts (Magisterial Areas) (Amendment) Instrument, 2004.

**2. Amendment of Statutory Instrument No. 23 of 1997. S.I. No. 23 of 1997**

The Magistrates' Courts (Magisterial Areas) Instrument, 1997 is amended in the Schedule—
