**The Uganda Wildlife (Amendment of Schedule)
Instrument, 2006.**

(Under section 7(4) of the Uganda Wildlife Act, Cap. 200).

IN EXERCISE of the powers conferred upon the Minister responsible for tourism, trade and industry by section 7(4) of the Uganda Wildlife Act, this Instrument is made this 17th day of May, 2005. Cap. 200.

1. This Instrument may be cited as the Uganda Wildlife (Amendment of Schedule) Instrument, 2006. Title.

2. Paragraph 1 of the Schedule to the Uganda Wildlife Act is amended by substituting for it the following new paragraph— Amendment
of Schedule
to Cap. 200.

“Composition
of Board

1. The Board shall consist of not more than nine members to be appointed from the following sectors—

(a) three members selected on the basis of their proven professional experience in—

(i) finance or economics;

(ii) management of large enterprises;

(iii) matters relevant to management of protected areas;

(b) a representative of tour operators;

(c) three representatives of the private sector involved in activities related to wildlife;

(d) the following *ex-officio* members to be appointed from the Ministry responsible for—

(i) wildlife; and

(ii) finance.”
