*Under Section 19(7) and (8)(b) of the Electoral Commission Act, Cap 140.*

IN EXERCISE of the powers conferred upon the Minister under section 19(7) and 8(b) of the Electoral Commission Act, Cap 140, this Instrument is made this 19th day of November, 2008.

**1. Title.**

This Instrument may be cited as the Electoral Commission (Appointment of Date of Completion of Update of Voters' Register in Bujumba County Constituency, Kalangala District and Sembabule District) Instrument, 2008.

**2. Appointment of date of completion.**
