The National Council for Higher Education (NCHE) is mandated under Section 5(i) of the Universities and Other Tertiary Institutions Act, 2001 to ensure minimum standards for courses of study and the equating of degrees, diplomas and certificates awarded by different public and private institutions of higher education.

In exercise of its powers, the NCHE issued Statutory Instrument No. 35 of 2008, (Basic Requirements and Minimum Standards for Procurement Education and Training) published in the Uganda Gazette, No. 45, Vol. CI dated 5th September, 2008.

The NCHE noted some omissions and errors and hereby certifies the same. The correct version therefore is—

### Schedule

Regulation 1.3(5) Minimum entry requirements for an ordinary diploma—

(a) Uganda Certificate of Education (UCE) with at least 5 passes.
