LICENCE REVOCATION NOTICE: WEST NILE
RURAL ELECTRIFICATION COMPANY (WENRECO)

The public, and especially those parties affected by WENRECO operations, are requested to take note that pursuant to Section 42 of the Electricity Act 1999 (Cap. 145, Laws of Uganda) the Authority at its 149th meeting resolved to give notice to West Nile Rural Electrification Company (WENRECO) that the Authority will consider revocation of Licence No. 019 issued to WENRECO in March, 2003 to generate, distribute and sell electricity in the West Nile Region of Uganda.

This notice invited WENRECO to show cause by 25th May, 2009 why the said licence should not be revoked due to the following breaches:

- (a) **Supply obligation:** Under the Licence No. 019 WENRECO must supply electricity for a minimum of 18 hours everyday. For the past one year this was not the case (and from 10th March 2009 WENRECO ceased supply all together) in breach of this existing licence obligation.
- (b) **Customer Connection Obligation:** Under the Licence No. 019 West Nile Rural Electrification Company (WENRECO) was expected to add at least 500 new clients in the first year of operation i.e. by March 2004. Additionally, WENRECO had to have connected cumulatively 4000 new clients to the grid by March 2008 which was not accomplished in breach of this existing licence obligation.
- (c) **Completion of the 5MW Nyagak Mini Hydropower Project:** Under the Licence, No. 019 WENRECO was expected to have developed and commissioned into operation the Nyagak Mini Hydropower Project by March 2006, which did not occur in breach of an existing licence obligation.

The Authority believes that WENRECO may not be in position to complete this project in spite of the numerous reasons advanced by WENRECO.

Additionally note that under Section 42(5) of the Electricity Act the Authority is empowered and "shall take such action as is necessary to ensure that the supply of service to consumers is not unduly interrupted as a result of the revocation" of WENRECO's Licence No. 019.







2. Amendment of jurisdiction of magistrates courts under section 2(1) of Cap. 156

The jurisdiction of magistrates courts under section 2(1) of the Administration of Estates (Small Estates) (Special Provisions) Act in the case of grant of probate or letters of administration in respect of small estates of deceased persons is amended as follows—

- (a) in the case of a Magistrate Grade I, it shall be where the total value of the estate does not exceed the maximum financial limit of the civil jurisdiction of a Magistrate Grade I under section 207 of the Magistrates Courts Act;

(b) in the case of a Chief Magistrate, it shall be where the total value does not exceed the maximum financial limit of the civil jurisdiction of the Chief Magistrate under section 207 of the Magistrates Courts Act.

IN EXERCISE of the powers conferred upon the Minister responsible for justice by section 8 of the Administration of Estates (Small Estates) (Special Provisions) Act, Cap.156 and in consultation with the Chief Justice, these Rules are made this 26th day of February, 2009.

1. Title

These Rules may be cited as the Administration of Estates (Small Estates) (Special Provisions) (Probate and Administration) (Amendment) Rules, 2009.

2. Amendment of S.I.156-1

The Administration of Estates (Small Estates) (Special Provisions) (Probate and Administration) Rules are amended, in rule 3, by inserting immediately after subrule (5) the following—

“(6) The magistrate shall, before making a grant of probate or letters of administration, satisfy himself or herself that the deceased person to whose estate the application relates had at the time of his or her death, a fixed place of abode within the jurisdiction of the court.

- (7) In all cases a magistrate may, if he or she thinks proper—
- (a) examine the petitioner in person, upon oath or solemn affirmation;
 - (b) require further evidence of the due execution of the will, or the right of the petitioner to the letters of administration, as the case may be; and
 - (c) issue citations calling upon all persons claiming to have any interest in the estate of the deceased to appear before the court before the grant of probate or letters of administration.

(8) A citation issued under subsection (7) shall be fixed up in a conspicuous part of the courthouse, and also in the offices of the district council, and otherwise published or made known in such manner as the court issuing it may direct.”.
