(Exemption) (No. 8) Order, 2010.**

*(Under section 135 of the Traffic and Road Safety Act, Cap. 361).*

IN EXERCISE of the powers conferred upon the Minister of Works and Transport by section 135 of the Traffic and Road Safety Act, 1998 Cap. 361 this Order is made this 21st day of September, 2010.

**1. Title.**

This Order may be cited as the Traffic and Road Safety Act (Speed of Motor Vehicle) (Exemption) (No. 8) Order, 2010.

**2. Exemption.**

A person who drives a motor vehicle and who competes in the UMMA sprint organised by the Federation of Motor Sports Club of Uganda (FMU) in conjunction with the Uganda Motorsport Marshals Association, to be held on the 26th September, 2010 at Lubiri - Mengo in the District of Kampala, is exempted from the provisions of section 120 of the Traffic and Road Safety Act, for the duration of the sprint.
