**The Traffic and Road Safety Act (Closure of Road) (Exemption)
(No. 2) Order, 2010.**

(Under section 175 of the Traffic and Road Safety Act, Cap. 361).

IN EXERCISE of the powers conferred upon the Minister of Works and Transport by section 175 of the Traffic and Road Safety Act, 1998, Cap. 361 this Order is made this 11th day of November, 2010.

1. Title.

This Order may be cited as the Traffic and Road Safety (Closure of Road) (Exemption) (No. 2) Order, 2010.

2. Exemption.

A person who takes part in the Annual Street Dance Promotion 2010 organised by Club Silk commencing on the 31st December, 2010 to 1st January, 2011 on 1st Street Industrial Area, Kampala, is exempted from the provisions of section 136 of the Traffic and Road Safety Act for the duration of the Street Dance Promotion.
