The Electricity Regulatory Authority (ERA) has under Section 29 of the Electricity Act 1999, Cap. 145 received a Notice of Intended Application for a Licence from Uganda Electricity Generation Company Limited for generation and sale of electricity from Nyagak River.

Uganda Electricity Generation Company Limited intends to generate approximately 4.4 MW of electricity along Nyagak River, about 7km to the north of Paidha town, in Nebbi District. The generated electricity will be sold to Uganda Electricity Transmission Company Limited and fed into the national grid.
