



The Traffic and Road Safety (Speed of Motor Vehicle) (Temporary Maximum Speed Limit) (No. 2) Order, 2013.

(Under sections 135 and 175 of the Traffic and Road Safety Act, 1998, Cap. 361).

IN EXERCISE of the powers conferred upon the Minister responsible for transport by sections 135 and 175 of the Traffic and Road Safety Act, 1998, Cap. 361, this Order is made this 6th day of March, 2013.

1. Title.

This Order may be cited as the Traffic and Road Safety (Speed of Motor Vehicle) (Temporary Maximum Speed Limit) (No. 2) Order, 2013.

2. Temporary maximum speed limit.

A temporary maximum speed limit is prescribed up to a limit of 160km per hour for a driver of motor vehicles, who compete in the MOSAC Sprint Rally 2013 organised by the Federation of Motor Sports Clubs of Uganda (FMU), in conjunction with the Motor Sports Club, on 1st April, 2013.

3. Exemption.

Subject to paragraph 2, a person who drives a motor vehicle and competes in the MOSAC Sprint Rally 2013, organised by the Federation of Motor Sports Clubs of Uganda (FMU), in conjunction with the Motor Sports Africa Club, on 1st April, 2013 at Festino Cite in Mukono District is exempted from the provisions of section 120 of the Traffic and Road Safety Act, and the Traffic and Road Safety (Speed Limits) Regulations, 2004 S.I No. 33 for the duration of the rally.
