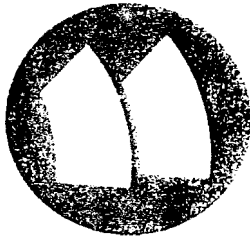

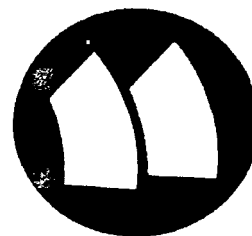

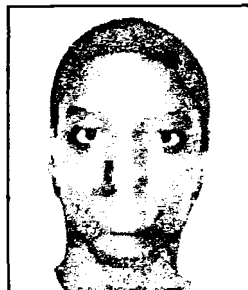

3. That I was foretold by my parents that soonafter my birth I was named **SEKINDI AISHA** and thereafter called and known by the said names.
4. That during the year 1984, I attended Kyato Moslem Primary School for my Primary Leaving Examinations.
5. That in 1985 I joined Kaddugala Senior Secondary School and sat for my O' Level examinations in 1988.
6. That during registration for the O' level examinations, I registered as **SEKINDI AISHA** but the religious name was mis-spelt on my results to read '**SEKINDI AYISA**'.
7. THAT further I joined Kibuli Teachers Training College in the year 1993 for a grade III teachers certificate and completed in the year 1995.
8. THAT during my registration at the T.T.C. I rectified the mistake on my religious name '**AYISHA**' by putting it right to read '**AISHA**'.
9. That all documents issued to me thereafter including Grade III Teachers Certificate, Certificate of Registration and pass-slip were issued in my true names of **SEKINDI AISHA**
10. That although there is a variance in the religious name on the documents aforementioned, I am the same person and holder thereon.
11. That I affirm to this solemn Declaration conscientiously believing the same to be true by virtue of the provisions of the Statutory Declaration Act of Laws of Uganda 2000.
