Article 17 of the constitution be amended by adding the offices of the LCV Chairperson and all party flag bearers who lost in the general elections from LC3 to Constituency level that are still members of the Party.

### NEW PROVISION

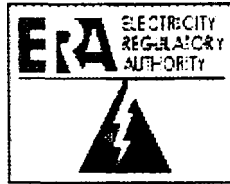

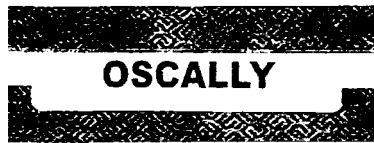
