The Traffic and Road Safety (Speed of Motor Vehicle) (Exemption) Order, 2017.

(Under section 175 of the Traffic and Road Safety Act, Cap 361).

IN EXERCISE of the powers conferred upon the Minister responsible for works and transport by section 175 of the Traffic and Road Safety Act, this Order is made this 21st day of April, 2017.

1. Title.

This Order may be cited as the Traffic and Road Safety (Speed of Motor Vehicle) (Exemption) Order, 2017.

2. Exemption.

A person who drives a motor vehicle and who competes in the 3rd National Rally Championship, organised by the Federation of Motor Sports Clubs of Uganda, commencing on the 28th day of April, 2017 and ending on the 30th day of April, 2017 is exempted from the provisions of section 120 of the Traffic and Road Safety Act, for the duration of that rally.
