IN EXERCISE of the powers conferred upon the Minister responsible for transport by Sections 135 and 175 of the Traffic and Road Safety Act 1998, Cap.361, this Order is made this 20th day of April, 2018.

**1. Title.**

This Order may be cited as the Traffic and Road Safety (Speed of Motor Vehicle) (Exemption) Order, 2018.

**2. Temporary Maximum speed limit.**

A temporary maximum speed limit is prescribed up to a limit of 180KM per hour for drivers of motor vehicles, who compete in the Southern Motor Club Rally to be held on 27th - 29th April, 2018.

**3. Exemption.**

Subject to paragraph 2, a person who drives a motor vehicle and who competes in the Southern Motor Club Rally to be held on 27th -29th April, 2018, in Masaka, Lwengo and Kyotera Districts, organized by the Federation of Motor Sport Clubs of Uganda (FMU), is exempted from the provisions of Section 120 of the Traffic and Road Safety Act, 1998 and the Traffic and Road Safety (Speed Limits) Regulations, 2004, S.I. No. 33 for the duration of the rally.
