**The Value Added Tax (Zero-Rated Educational Materials)
Regulations, 2018.**

*(Under section 78 and paragraph 4 (a) of the Third Schedule to the Value
Added Tax Act Cap. 349)*

IN EXERCISE of the powers conferred upon the Minister responsible for finance by section 78 and paragraph 4 (a) of Third Schedule of the Value Added Tax Act, these Regulations are made this 3rd day of August, 2018.

1. Title.

These Regulations may be cited as the Value Added Tax (Zero-Rated Educational Materials) Regulations, 2018.

2. Value added tax zero-rated educational materials.

The following supplies are specified as educational materials for purposes of paragraph 4(a) of the Third Schedule to the Value Added Tax Act—

- (a) crayons;
- (b) colored pencils;
- (c) lead pencils;
- (d) pencil sharpeners;
- (e) chalk boards;

- (f) chalk;
- (g) rulers;
- (h) geometry/ mathematical sets;
- (i) erasers;
- (j) ball point pens;
- (k) exercise books with soft or hard cover in all sizes;
- (l) graph books;
- (m) duplicating paper;
- (n) stencils;
- (o) chalkboard instruments;
- (p) ruled paper;
- (q) school registers or school books of soft or hard cover and in all sizes;
- (r) examination paper supplied to examination boards as end user;
- (s) examination envelopes supplied to examination boards as end user;
- (t) science related educational materials;
- (u) technical drawing sets; and
- (v) laboratory chemicals for the teaching of science subjects.
