## AMENDMENT OF SECTION 5.11 OF THE HUMAN RESOURCES MANUAL

At the 142nd Meeting of the Makerere University Council held on 24th May, 2018, Section 5.11 of the Makerere University Human Resources Manual (2009) was amended and substituted with the following:

### 5.11 EMPLOYEES FACING CRIMINAL CHARGES

- Where criminal proceedings are instituted against an employee in any Court of Law, the employer shall be at liberty to institute an investigation and take disciplinary proceedings against him/her.
- Nothing shall be construed as prohibiting or restricting the Appointing Authority from exercising its powers to take disciplinary action against an employee who is facing criminal proceedings and subject such an employee to any form of punishment including termination, suspension or any other appropriate sanction.
- Upon suspension, the employee shall be on half salary until the conclusion of the investigation and disciplinary proceedings by the Employer.
- An employee convicted of a criminal offence shall be deemed to have been summarily dismissed. However, an employees' acquittal by the Courts of Law does not in any way affect the decision made by the Employer during its internal disciplinary process.
