**THE TRAFFIC AND ROAD SAFETY ACT, 1998  
(AMENDMENT) ACT, 2023**

**An Act to amend the Traffic and Road Safety Act, 1998 Cap. 361, by substituting for the word “date”, the word “year” in sections 14A and 14B; by repealing paragraphs (a), (b) and (f) of section 178; by substituting for the word “Board” wherever the word appears, the words “Competent Authority”; by substituting for the words “Secretary to the Board” wherever the words appear, the word “Commissioner”; and for related matters.**

DATE OF ASSENT: 17th August, 2022

*Date of Commencement:* 1st July, 2022

BE IT ENACTED by Parliament as follows—

**1. Commencement**

This Act shall come into force on 1<sup>st</sup> July, 2022.

**2. Amendment of Traffic and Road Safety Act, 1998**

The Traffic and Road Safety Act, 1998 Cap. 361 in this Act referred to as the principal Act is amended in section 2 (1), by inserting immediately after the definition of “chief licensing officer” the following—

“Commissioner” means the Commissioner responsible for transport regulation and safety;”

**3. Amendment of section 14A of principal Act**

Section 14A of the principal Act is amended in subsection (1), by substituting for the word “date”, the word “year”.

**4. Amendment of section 14B of principal Act**

Section 14B of the principal Act is amended in subsection (1), by substituting for the word “date”, the word “year”.

**5. Amendment of section 178 of principal Act**

Section 178 of the principal Act is amended in subsection (2), by repealing paragraphs (a), (b) and (f).

**6. Miscellaneous amendments to principal Act**

The principal Act is amended—

- (a) by substituting for the word “Board” wherever the word appears, the words “Competent Authority”; and
- (b) by substituting for the words “Secretary to the Board” wherever the words appear, the word “Commissioner”.

**7. Amendment of Fourth Schedule to principal Act**

The principal Act is amended in the Fourth Schedule by substituting for the word “date” wherever the word appears, the word “year”.
