**SCHEDULE****Definition**

1. In these Rules "the Rules" mean the Rules published in Provincial Notice No. 273 of 8 August 1996, as amended by Provincial Notices Nos 45 of 31 October 1996, 125 of 9 April 1998, 275 of 25 September 1998, 170 of 8 June 2000, 376 of 5 October 2000, 176 of 17 May 2001, 258 of 6 July 2001, 223 of 20 June 2002, 228 of 20 June 2002, 1135 of 18 November 2003, 864 of 29 July 2004 and 905 of 30 July 2004.

**Amendment of Rule 11**

2. The following Rule is hereby substituted for Rule 11:

"The quorum of a meeting of the General Committee shall consist of twenty representatives of each of the three funds appointed or elected in accordance with Rule 2. Should a quorum of a Fund not be present at ~~[any meeting]~~ the determined time for the meeting of the General Committee, ~~[such meeting]~~ the business of the meeting shall continue for the Fund or Funds for which the required quorum is present, and the meeting of the General Committee of the Fund or Funds for which a quorum is not present, shall be adjourned for a maximum period of 90 days to a date and place determined by the Chairman in consultation with the Director[.] : Provided that—

- (a) the Chairman of the meeting of the General Committee shall decide whether any matter for decision affects all three Funds, two Funds or only one Fund;
- (b) in the event that such later date is a public holiday, the meeting shall be held on the first business day after such public holiday; and
- (c) In the event that the required quorum is not present at such adjourned meeting, the business of the meeting shall be decided by those present at the meeting.
