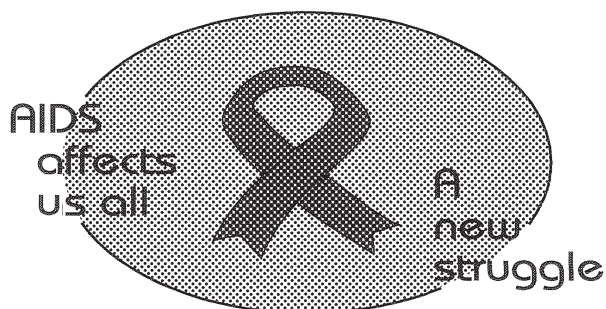

**PROCLAMATION 2 OF 2019****PROCLAMATION***by the**Premier of the Province of KwaZulu-Natal***CALLING AND SETTING A DATE FOR AN ELECTION, AND DISSOLUTION, OF THE PROVINCIAL LEGISLATURE OF KWAZULU-NATAL IN TERMS OF SECTIONS 108(2) AND 109(1) OF THE CONSTITUTION OF THE REPUBLIC OF SOUTH AFRICA, 1996**

In terms of sections 108(2) and 109(1) of the Constitution of the Republic of South Africa, 1996, read with section 18 of the Electoral Act, 1998 (Act No. 73 of 1998), and –

(a) after consultation with the Electoral Commission; and

(b) pursuant to the adoption, on 22 February 2019, by the Provincial Legislature of KwaZulu-Natal of a resolution to dissolve,

I hereby dissolve the Provincial Legislature of KwaZulu-Natal, call an election for the Provincial Legislature of KwaZulu-Natal and set 8 May 2019 as the voting day.
