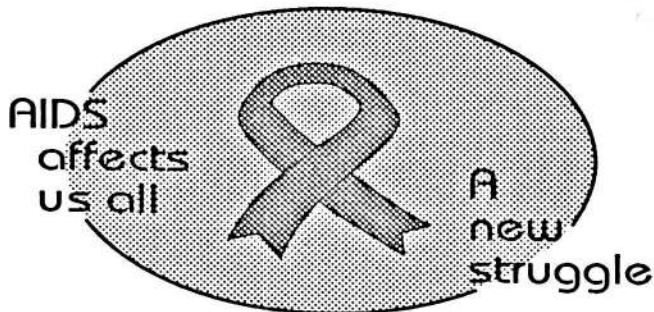

NOTICE OF LAND DEVELOPMENT AREA APPLICATION

Northplan Town and Regional Planners (Applicant) has lodged an application in terms of the Development Facilitation Act, 1995, for the establishment of a land development area on a portion of the Farm Moeijelik 412 KS.

The development will consist of the following: A township with the following erven and uses: 1 020 residential, 12 flats, 21 light industrial/commercial, 98 business, 31 business/commercial, and 1 each for temporary accommodation, taxi rank, garage, school, municipal, police/government, community facility, hospital, lodge, churches, private and public open space (1 194 in total).

The relevant plans, documents and information are available for inspection at 28 Market Street, Polokwane and land development applicant for a period of 21 days from 3 January 2003.

2. If your comments constitute an objection to any aspect of the land development application, you must appear in person or through a duly authorised representative before the Tribunal at the pre-hearing conference.

PHALABORWA AMENDMENT SCHEME 104

(SUBDIVISION OF PORTION 9 OF ERF 1810, PHALABORWA EXTENSION 1)

It is hereby notified in terms of the provisions of section 57 (1) (a) of the Town-Planning and Townships Ordinance, 1986 (Ordinance 15 of 1986), that the Ba-Phalaborwa Municipality has approved the amendment of the Phalaborwa Town-Planning Scheme, 1981, by the rezoning of the Remainder of Portion 9 of Erf 1810, Phalaborwa Extension 1 from "Residential 1" with a density of "One dwelling house per Erf" to "Special" for a home office and a dwelling unit (proposed portion A) as well as "Business 3" (proposed portions B-D).
