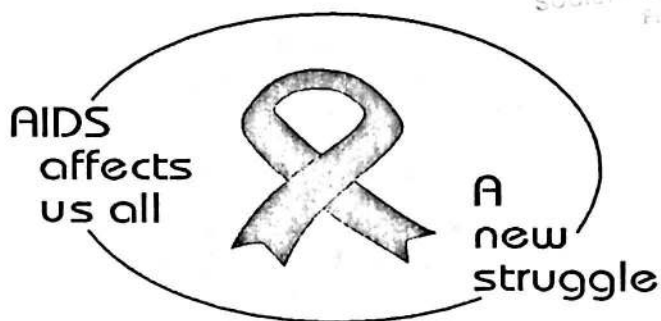

NOTICE 135 OF 2000

GENERAL PROVISIONS

1. Substitute the whole sentence with: **"These amended regulations shall come into effect on the date of the publication of this notice"**.

2. (1) Substitute Northern with: **"Limpopo"** and May and July with: **"June and August 2003"**.

NOTICE 140 OF 2000

NOTICE OF DETERMINATION OF GUIDELINES FOR ESTABLISHMENT, ELECTIONS OF REPRESENTATIVE COUNCILS OF LEARNERS

SCHEDULE

Definitions

1. In the heading written in bold and capital letters immediately below section 1, substitute REPRESENTATIVES with: **"REPRESENTATIVE"** and COUNCIL with **"COUNCILS"**.

2. (1) Substitute will with **"shall"**.

2. (9) Insert subregulation 2 (9) after subregulation 2 (8), which reads as follows: **"The election of Representative Councils of learners in all Public Ordinary Schools offering Grade 8 and higher, in the Limpopo Province, will be conducted between January and February every year"**.

3. (5) Insert the word **"serious"** before misconduct.

4. (2) Delete verbally or and insert **"in writing"** after the word obtained.

4. (5) Change nomination to **nominations**. Delete prominently and substitute it with **"on the Class Notice Board"**.

6. (2) Delete the whole sentence and substitute it with: **"No member of the Representative Council of Learners, in any given term of office, shall hold more than one portfolio in the Executive Committee of the Representative Council of Learners"**.

7. (a) Substitute built with **"bulld"**.

8. (5) Substitute on before elected with **"an"**.

Immediately after 8 (5), delete the whole proforma and substitute it with: **"NOTICE CALLING FOR THE NOMINATION AND ELECTION OF CLASS REPRESENTATIVES TO THE RCL"**.

A nomination and election meeting for your representative on the RCL shall be held in this classroom on (day) the (date) at (time)

This class may elect one/two (delete which is not applicable) representative to the RCL. The election will be by secret ballot and each learner shall have one vote for each representative from this class.

Nominations for representatives shall be in writing at the meeting, and must be seconded. The person so nominated must agree to be on the RCL.

REGULATIONS RELATING TO GOVERNING BODIES OF PUBLIC SCHOOLS

CHAPTER 1

TERM OF OFFICE OF A GOVERNING BODY

8.1 Delete whole sentence and substitute it with: "The Head of Department may remove a member(s) of a governing body from office if he or she is of the opinion that such a removal is in the best interest of the school".

8.2 (a) Delete and substitute with: "Informed that/those member(s) of the governing body of the school, in writing, of his/her intention so to act and the reasons thereof.

8.2 (b) Delete and substitute with: "granted that/those member(s) of the governing body of a school a fourteen days grace period to make written representation to him/her in relation to such action.

CHAPTER 4

Insert the subheading: "DEFINITION OF TERMS AND ACRONYMS USED".

NUMBER OF MEMBERS OF SCHOOL GOVERNING BODIES ACCORDING TO SIZE.

SCHEDULE B
