The Request for Proposals for a Casino Licence (“RFP”) published by the Mpumalanga Economic Regulator (“MER”) on 16 September 2022, included the process that the MER will follow to consider proposals for a casino licence, and provided an opportunity for clarification questions up to 17 October 2022.
