THABA CHWEU AMENDMENT SCHEME 43/2018**

It is hereby notified in terms of Section 66(5) of the Thaba Chweu Spatial Planning and Land Use Management By-law, 2015 that Thaba Chweu Local Municipality approved the amendment of the Thaba Chweu Land Use Scheme, 2018, by the rezoning of Erf 313, Graskop Township (38 Hugenote Street), from "Special" to "Residential 3" with a density restriction of 40 dwelling units per hectare, as primary land uses with Annexure conditions as set out in the Schedule.
