STORAGE OR DEPOSITING OF MATERIAL AND THE
PREVENTION AND SUPPRESSION OF NUISANCES****Definitions****1. In this by-law—**

"Council" means the Municipal Council of Loxton;

"public place" means and includes any public street or place, public conveyance, place of public entertainment or resort, or place which is open to public view; and

"public street" means any street, road, highway, thoroughfare, lane, footpath, sidewalk, alley, passage, square, bridge or any other place of a like nature or any portion thereof, and includes any appurtenance thereto.

Disturbance of the peace

2. (1) No person shall at any time of the day or night disturb the public peace in any public place by making unseemly noises, or by being rowdy, shouting, insistently hooting, wrangling or quarrelling, or by collecting a crowd, or by fighting or challenging to fight, or by striking with or brandishing or using in a threatening manner any stick or other weapon, or by any other riotous, violent or unseemly behaviour.

(2) No person shall advertise wares or services in any public place by means of any megaphone, loud-speaker or other similar device, or by insistent shouting, striking of gongs, blowing of horns or ringing of bells in such manner as to constitute a public nuisance in the neighbourhood.

LASTE****Woordomskrywing****1. In hierdie verordening—**

beteken en omvat **"openbare plek"** 'n openbare straat of plek, openbare vervoermiddel, 'n openbare vermaaklikheidsplek of plek van openbare samekoms, of 'n plek in die openbare gesig;

Verstoring van rus

2. (1) Niemand mag te eniger tyd gedurende die dag of nag die openbare vrede in 'n openbare plek versteur deur onbetaamlike geluide te maak, of deur te raas, te skreeu, aanhoudend te toeter, te twis of rusie te maak, of deur 'n skare mense byeen te bring, of deur te baklei of tot 'n bakleiery uit te daag, of deur met 'n stok of ander wapen te slaan of dit te swaai of op 'n dreigende wyse te gebruik, of deur enige ander oproerige, gewelddadige of onbetaamlike gedrag nie.

(2) Niemand mag ware of dienste in 'n openbare plek adverteer deur middel van 'n megafoon, luidspreker of ander dergelike toestel, of deur aanhoudend te skree, op 'n ghong te slaan, toeters te druk of klokke te lui op so 'n wyse dat dit 'n openbare oorlas in 'n buurt uitmaak nie.

(3) No person, being in or on any private premises, shall disturb the public peace in the neighbourhood of such premises by making therein or thereon any unseemly noise, shouting, quarrelling, wrangling or singing, or the continuous playing of musical instruments, record players or the like, or by the continuous or overloud use of loudspeakers, radios or the like, or by fighting, or by using obscene language.

(4) No person shall in any public place use any abusive or threatening language or commit any act which is liable or calculated to cause a breach of the peace.

Animals and birds

3. (1) No person shall keep on his premises any animal or bird which, by reason of continued barking, yelping, howling, crowing or any other noises, disturbs the public peace or is a source of nuisance to the neighbourhood, after the expiration of a period stipulated in a notice, which is signed by the Town Clerk and served upon him, and which require him to abate such disturbance or nuisance.

(2) No person shall allow any dog or other animal, of which he is the owner or in charge, to charge at horses, pedestrians, motor-cars or cyclists, or allow such dog or other animal to interfere with the comfort or safety of the public.

(3) No person shall keep on any premises any wild, ferocious or dangerous animal unless such animal is securely tied up or confined.

Prohibited actions

4. (1) No person shall deposit, leave, spill, drop or place any fruit peels, broken glass or paper or any other matter or thing likely to interfere with the cleanliness of any park, garden, camping area or street, or cause annoyance, danger or injury to persons in such park, garden, camping area or street.

(2) No person shall throw or deposit or allow to be thrown or deposited any broken bottle, glass or earthenware, or any fruit or vegetable peelings, or any refuse in or on any street, footpath or public place.

(3) No owner or occupier of any shop or business premises or vacant land adjoining such shop or business premises shall use or cause or allow to be used any stoep or veranda of such shop or business premises or vacant land adjoining such shop or business premises for the purpose of storing, stacking, dumping, disposing of, displaying, keeping, selling or offering for sale any goods, articles or merchandise.

(4) No owner or occupier of any shop or business premises or vacant land adjoining such shop or business premises shall use or cause or allow to be used such shop or business premises or vacant land adjoining such shop or business premises or any portion thereof which is open or visible to the public, for the purpose of storing, stacking, dumping, disposing of or keeping any waste material, refuse, crates, cartons, containers or other articles of like nature.

(5) No owner or occupier of any shop or business premises shall enclose or cause or allow to be enclosed any stoep or veranda of such shop or business premises by means of movable or immovable structures, objects, articles or devices, otherwise than by building enstructions of a permanent nature which shall be erected in accordance with plans bearing the approval of the Town Clerk.

Diere en voëls

3. (1) Na verstryking van 'n tydperk vermeld in 'n kennisgewing wat deur die stadsklerk onderteken en aan iemand beteken is en waarin hy versoek word om 'n steurnis of oorlas te verhelp, mag niemand op sy perseel enige dier of voël aanhou wat weens 'n voortdurende gebela, gekef, getjank, gekraai of deur ander geluide te maak, die openbare vrede verstoort of vir die omgewing 'n bron van ergernis is nie.

(2) Niemand mag toelaat dat 'n hond of ander dier wat aan hom behoort of onder sy toesig is, op perde, voetgangers, motors of fietsryers afstorm of toelaat dat sodanige hond of ander dier die gerief of veiligheid van 'n lid van die publiek belemmer nie.

(3) Niemand mag op enige perseel enige wilde, wrede of gevaarlike dier aanhou nie tensy sodanige dier stewig vasgemaak of opgesluit is.

Verbode handelings

4. (1) Niemand mag enige vrugteskille, glasstukke of papier of enige stof of ding wat waarskynlik die skoon toestand van enige park, tuin, kampeergebied of straat sal benadeel of ergernis, gevaar of besering aan persone in sodanige park, tuin, kampeergebied of straat sal veroorsaak, plaas, laat bly, uitstort, neergooi of neersit nie.

(2) Niemand mag enige gebreekte bottel, glas of erdeware, of enige vrugte- of groenteskille, of enige vullis in of op enige straat, voetpad of openbare plek gooi of plaas of toelaat dat dit daarin of daarop gegooi of geplaas word nie.

(3) Geen eienaar of okkupeerder van enige winkel of sakeperseel of onbeboude grond wat aan sodanige winkel of sakeperseel grens, mag enige stoep of veranda van sodanige winkel of sakeperseel of onbeboude grond wat aan sodanige winkel of sakeperseel grens, gebruik of laat gebruik of toelaat dat dit gebruik word vir die doel om enige goedere, artikels of handelsware op te berg, op te stapel, te stort, weg te doen, uit te stal, te hou, te verkoop of vir verkoop aan te bied nie.

(4) Geen eienaar of okkupeerder van enige winkel of sakeperseel of onbeboude grond wat aan sodanige winkel of sakeperseel grens, mag sodanige winkel of sakeperseel of onbeboude grond wat aan sodanige winkel of sakeperseel grens of enige gedeelte daarvan wat vir die publiek toeganklik of sigbaar is, gebruik of laat gebruik of toelaat dat dit gebruik word vir die doel om enige afvalmateriaal, vullis, kratte, kartondose, houters of ander artikels van 'n dergelike aard op te berg, op te stapel, te stort, weg te doen of te hou nie.

Penalty

5. Any person contravening any provision of this by-law shall be guilty of an offence and liable on conviction to a penalty not exceeding R100 and, in the event of a continuing offence, to a further penalty not exceeding R10 for each day on which such offence continues after written notice of not less than seven days has been given by the Council to such person.

MUNICIPAL NOTICE 52**VICTORIA WEST MUNICIPALITY****BY-LAW RELATING TO THE PREVENTION AND
SUPPRESSION OF NUISANCES****Definitions**

1. In this by-law—

"Council" means the Municipal Council of Victoria West;

"public place" means and includes any public street or place, any public conveyance, any place of public entertainment, any place of public gathering, or any place which is open to public view; and

"public street" means any street, road or highway, thoroughfare, lane, footpath, sidewalk, alley, passage, square, bridge or any other place of a like nature or any portion thereof, and includes any appurtenance thereto.

Disturbance of the peace

2. (1) No person shall at any time of the day or night disturb the public peace in any public place in Victoria West by making unseemly noises, or by being rowdy, shouting, insistently hooting, wrangling or quarrelling, or by collecting a crowd, or by fighting or challenging to fight, or by striking with or brandishing or using in a threatening manner any stick or other weapon, or by any other riotous, violent or unseemly behaviour.

(2) No person shall advertise wares or services in any public place in Victoria West by means of any megaphone, loud-speaker or other similar device, or by insistent shouting, striking of gongs, blowing of horns or ringing of bells in such manner as to constitute a public nuisance in the neighbourhood.

(3) No person, being in or on any private premises, which is situated in Victoria West shall disturb the public peace in the neighbourhood of such premises by making therein or thereon any unseemly noise, shouting, quarrelling, wrangling or singing, or by incessantly playing musical instruments, record players or the like, or by using incessantly or overloud any loudspeakers, radios or the like.

(4) No person shall in any public place in Victoria West use any abusive or threatening language or commit any act which is liable or calculated to cause a breach of the peace.

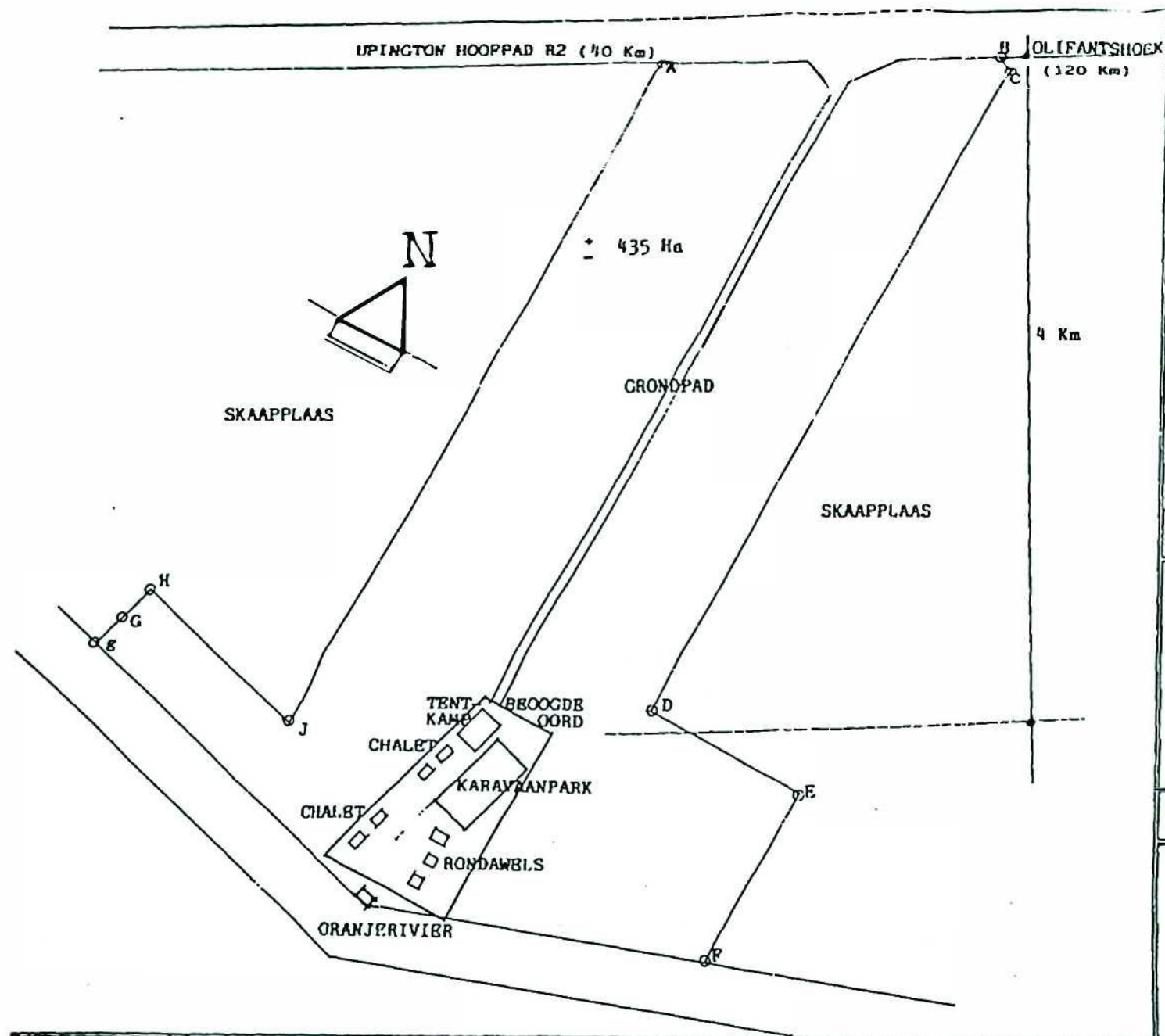
