Under section 83 (1) (a) and with retention of the provisions of section 83 (1) (b) of the Municipal Ordinance, 1974 (Ordinance No. 120 of 1974), I hereby declare that for the period 1 July 1995 to 30 June 1999, only 1% of the general rate determined and levied by the Municipality of Upington, shall be payable in respect of the following useful improvements on agricultural properties in the municipal area of which the erven numbers are set out in the Schedule hereto, provided that full rates will be levied on any of the properties when they are no longer used for *bona fide* farming purposes.
