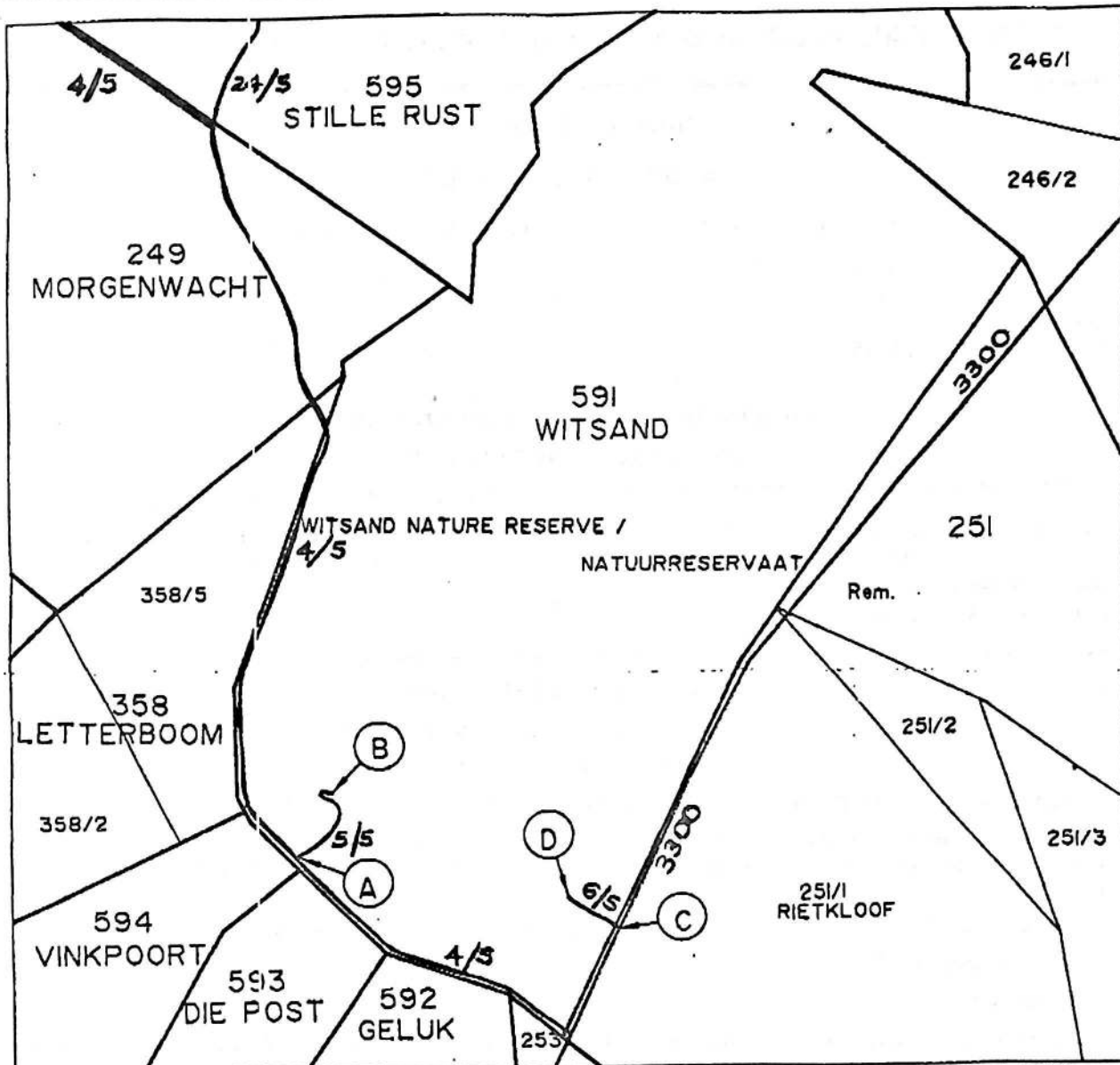

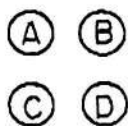

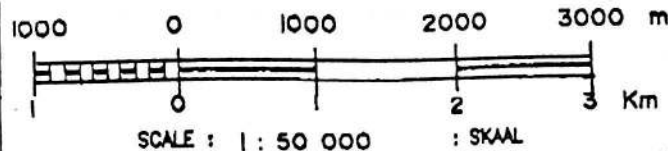


Proposed closure of Minor Roads.
