ROADS ORDINANCE, 1976 (ORDINANCE No. 19 OF 1976)

BENEDE-ORANJE DISTRICT COUNCIL: DECLARATION OF PUBLIC ROAD

Under section 3 of the Roads Ordinance, 1976 (Ordinance No. 19 of 1976), I hereby declare the existing concession road described in the Schedule and situated within the Benede-Oranje District Council Area, the location and route of which is as indicated by means of a broken blue line marked AB on plan RL 43/1, which is filed in the offices of the Chief Director: Department of Transport, 22 Fabricia Road, Kimberley, and the Benede-Oranje District Council, Upington, shall be declared a minor road.

VICTORIA WEST MUNICIPALITY

AMENDMENT TO THE STANDARD STAFF LEAVE BY-LAW

The Standard Staff Leave By-law, published under Provincial Notice No. 62 dated 28 January 1966, as amended and adopted by the Municipal Council of Victoria West under Provincial Notice No. 673 dated 24 June 1966, is hereby amended in so far as it applies to the Victoria West Municipality by the substitution for section 13 of the following section:

"Conversion into cash of certain vacation leave

13. Any employee may at any time convert any vacation leave standing to his credit into cash, subject to the following conditions:

- (a) A minimum of ten (10) days shall be converted per occasion;
- (b) after vacation leave has been converted into cash, an employee shall have at least ten (10) days to his credit; and
- (c) should the employee owe any monies to the Council, the Council may withhold such payment of leave as security towards monies owed unless the employee provides the Council with alternative security towards the monies owing to the Council."

WYSIGING VAN DIE STANDAARDVERORDENING INSAKE PERSONEELVERLOF

Die Standaardverordening insake Personeelverlof, gepubliseer by Provinsiale Kennisgewing No. 62 van 28 Januarie 1966, soos gewysig en aangeneem deur die Munisipale Raad van Victoria-Wes by Provinsiale Kennisgewing No. 673 van 24 Junie 1966, word hierby gewysig vir sover dit op die Munisipaliteit van Victoria-Wes van toepassing is deur artikel 13 deur die volgende artikel te vervang:

"Omsetting in kontant van sekere vakansieverlof"

13. 'n Werknemer kan te eniger tyd enige van die vakansieverlof wat hy te goed het in kontant omsit, onderworpe aan die volgende voorwaardes:

- (a) 'n Minimum van tien (10) dae moet per geleentheid omgesit word;
- (b) nadat vakansieverlof in kontant omgesit is, moet die werknemer ten minste tien (10) dae te goed hê; en
- (c) sou die werknemer enige gelde aan die Raad verskuldig wees, behou die Raad die reg voor om sodanige verlof as sekuriteit vir hierdie gelde in reserwe te mag hou tensy die werknemer alternatiewe sekuriteit kan voorlê ten opsigte van die gelde verskuldig aan die Raad."
