**AMENDMENT OF THE ROAD TRAFFIC REGULATIONS: INCREASE IN THE TARIFFS  
IN RESPECT OF MISCELLANEOUS FEES**

Under the powers vested in me by Proclamation No. R. 60, 1996, and subject to the provisions of the Northern Cape Act on the Delegation of Procedures, 1994 (Act No. 4 of 1994), I hereby amend the miscellaneous fees as set out in Schedule 1 of the Road Regulations, promulgated in terms of section 132 (1) (w) of the Road Traffic Act, 1989, in so far as it is applicable in the Province of the Northern Cape by substituting it with the following Schedule with effect from 1 March 1998.
