PROCLAMATION • PROKLAMASIE**PROCLAMATION****No. 12, 1998****PROVINCE OF THE NORTHERN CAPE****BO-KAROO DISTRICT COUNCIL: DECLARATION OF A PUBLIC ROAD**

Under sections 3 and 4 of Roads Ordinance, 1976 (Ordinance No. 19 of 1976), and section 7 of the Advertising on Roads and Ribbon Development Act, 1940 (Act No. 21 of 1940), I hereby declare the portion of road, situated within the Bo-Karoo District Council area, the location and route of which are as indicated by means of broken green line marked AB on Plan RL 41/57, which is filed in the offices of the Department of Transport, 22 Fabricia Road, Kimberley, and the offices of Bo-Karoo District Council, De Aar:

- (i) A public road with divisional road status; and
- (ii) proclaim the road described in the Schedule to be a building restriction road for the purposes of said Act No. 21 of 1940.

OFFICIAL NOTICE • OFFISIËLE KENNISGEWING**OFFICIAL NOTICE 33 OF 1998****DOUGLAS MUNICIPALITY****BY-LAWS FOR THE SUPERVISION AND MANAGING FOR THE BUSINESS OF
STREET TRADERS, VENDORS OR HAWKERS****Definitions**

1. Unless the context indicates otherwise, any word or expression when defined in the Business Act, 1991 (Act No. 71 of 1991), has that meaning and in these by-laws—

- A. "Council" means the City Council of Douglas;
- B. "garden" means a garden or park to which the public has a right of access;
- C. "goods" includes a living thing and any transferable interest;
- D. "litter" includes any container or other matter which has been discarded, abandoned or left behind by a person trading or his customers;
- E. "national monument" means a building declared to be a national monument under the National Monuments Act, 1969 (Act No. 28 of 1969);
- F. "nuisance" means any behaviour which can cause a situation that will be a hazard for a person or property or that of other people, or that can interfere with their usual comfort, convenience, calm or peace;
- G. "officer" means—
(a) a traffic officer appointed under section 3 of the Road Traffic Act, 1989 (Act No. 29 of 1989);
(b) a member of the Force defined in section 1 (1) of the Police Act, 1958 (Act No. 7 of 1958);
(c) a peace officer contemplated in section 334 of the Criminal Procedure Act, 1977 (Act No. 51 of 1977);
- H. "prohibited area" means any place declared or to be declared under section 6A (2) of the Act by resolution of the Council to be an area in which street trading may be prohibited;
- I. "property", in relation to a person carrying on the business of street trading, means an article, receptacle vehicle or structure used or intended to be used in connection with such business, and includes goods in which he trades;
- J. "public building" means a building occupied solely by the State or the Council;
- K. "public place" means a public place as defined in section 2 of the Local Government Ordinance, 1974 (Ordinance 20 of 1974);
- L. "public road" means any road, street, passage or any other place (either a passage or not), which is usually used by the public, either partly or not, whereto the public has access and also—
(a) the verge of any road, street or passage;
(b) any bridge, pond or drift through which or where over such road, street or passage may go;
(c) any other work or object which are part of or belongs to that road, street, or passage;
- M. "restricted area" means any place declared under section 6A (2) of the Act by resolution of the Council to be an area in which street trading may be restricted;
- N. "sell" includes supply and also—
(a) exchange or hire;
(b) store, expose, offer or prepare for sale, and "sale" has a corresponding meaning;
- O. "services" means any system through or on behalf of the local authority for the gathering, draining, treatment or disposal of refuse, sewerage or stormwater or for the production, generation, retention, storage, purifying, distribution, conducting, transmission, transport, provision or supplying of water, gas or electricity.
- P. "sidewalk" means a sidewalk as defined in section 1 of the Road Traffic Act, 1989 (Act 29 of 1989);
- Q. "the Act" means the Business Act, 1991 (Act 71 of 1991);
- R. "trade" means to sell goods or services in a public road or public place, and "trading" has a corresponding meaning;
- S. "verge" means a verge as defined in section 1 of the Road Traffic Act, 1989 (Act 29 of 1989) and any word or expression to which a meaning has been assigned in the Business Act, 1991, shall have that meaning.

For the purposes of these by-laws a person who is carrying out the business of street trading, vending or hawking includes any employee of any such person and any act of selling in a public place, shall constitute trading.

Freedom of trade

2. Subject to the provisions of sections 3 and 4 and any other act relating hereto, the business activities of street traders are freely permitted, except when it is prohibited by sections 5 to 12 as well as sections 14 and 15.

General conduct

3. A person who is doing the business of street trader, vendor or hawker shall—
(a) not place his property on a verge or public place except for the purpose of commencing to trade;
(b) ensure that his property does not cover an area of a public road or public place which is greater in extent than three metres long or two metres wide;
(c) not place or stack his property in such manner that it constitutes a danger to any person or is likely to injure any person;

- (d) place his property in such manner as not to obstruct any entrance to any service or fire hydrant;
- (e) on concluding business for the day remove his property to a place which is not part of a public road or public place;
- (f) not display his goods or other property on a building or other private property, without the consent of the owner, occupier or person in control of such building or property;
- (g) on request by an employee or agent of the Council or any supplier of telecommunications or electricity or other services, move his property as to permit the carrying out of any work in relation to a public road, public place or any such service;
- (h) not attach any object by any means to any building, structure, pavement, tree, parking meter, lamp-pole, electricity pole, telephone booth, post box, traffic sign, bench or any other street furniture in or on a public road or public place;
- (i) not make a fire at place or in circumstances where it could harm any person or damage a building or vehicle or any street furniture referred to in paragraph (h);
- (j) not store his property in a manhole or stormwater drain;
- (k) not spend the night on the place of business;
- (l) not erect any structure providing shelter (excluding an appliance which in appearance and functioning resembles an umbrella) without the prior approval of the Council.

Cleanliness of place of business and the protection of public health**4. A person who is doing the business of a street trader, vendor or hawker shall—**

- (a) keep the area or site occupied by him for the purpose of such business in a clean and sanitary condition;
- (b) keep his property in a clean and sanitary condition;
- (c) properly dispose of litter generated by his business through refuse bins supplied by the Council;
- (d) not dispose of litter in a manhole, stormwater drain or other place not intended for the disposal of litter;
- (e) ensure that on completion of business for the day, the area or site occupied by him for purposes of trade is free of litter, and in a hygienic condition;
- (f) in the case of a vendor of foodstuffs, take such precautions as may be necessary to prevent the spilling onto a public road or public place or any fat, oil or grease in the course of conducting his business and to prevent any smoke, fumes or odours emanating from his activities from becoming a nuisance;
- (g) on request by an employee or agent of the Council move his property so as to permit the cleansing of the surface of the area or site where he is trading;
- (h) conduct this business in such a way not to cause any hazard to public health or safety.

Obstruction of pedestrians**5. No person shall trade at a place where—**

- (a) it obstructs access to street furniture such as a bus passenger bench or shelter or queuing line, a refuse disposal bin or other facility intended for the use of the general public;
- (b) it obstructs the visibility of a display window in business premises, if the person carrying on business in the business premises concerned, objects thereto;
- (c) it obstructs access to an entrance to or exit from a building or a automatic bank teller machine;
- (d) it obstructs access to a pedestrian crossing;
- (e) it obstructs access to any vehicle;
- (f) it leaves less than one and a half metres in width of a sidewalk clear for pedestrian use; or
- (g) it in any other manner substantially obstructs pedestrians in their use of a sidewalk.

Obstruction of vehicular traffic**6. No person shall trade at a place where—**

- (a) it causes an obstruction on a roadway;
- (b) it limits access to parking or loading bays or other facilities for vehicular traffic;
- (c) it obscures any road traffic sign or any marking, notice or sign displayed or made in terms of these by-laws; or
- (d) it interferes in any way with any vehicle that may be parked alongside such place.

Trading restricted to specified hours in certain places**7. No person shall trade—**

- (a) on a verge contiguous to any place of worship, national monument or public building; or
- (b) outside the area as specified in Schedule A or outside the hours specified in relation to such area.

No trading in stands or areas which have been let except by the lessee

8. If the Council has let or otherwise allocated any stand or area set apart or otherwise established for street trading purposes, as contemplated in section 6A (3) (c) of the Act, no person may trade on such stand or in such area if he is not in possession of proof that he has hired such stand or area from the Council or that it has otherwise been allocated to him.

No trading near public buildings, places of worship and national monuments

9. No person shall trade on a verge contiguous to any place of worship, national monument or public building.

No trading in prohibited areas

10. No person shall trade in any prohibited area.

Signs indicating restrictions and areas

11. The Council shall—
- (a) by resolution prescribe signs, markings or other devices indicating—
 - (i) specified hours, places, goods or services in respect of which street trading is restricted;
 - (ii) the location or boundaries of a restricted area;
 - (iii) the boundaries of a stand or area set apart for the purposes of the carrying on of the business of street trading under section 6A (3) (b) of the Act;
 - (iv) the location or boundaries of the prohibited areas.
 - (b) display any such sign, marking or device in such a position and manner as will indicate the restriction or the location or boundaries of the area or stand concerned.

Trading near certain business premises

13. No person shall trade on a verge contiguous to that part of a building in which business is being carried on by a person other than a department store or supermarket or other large supplier of many different lines of goods, and who, as one of this principal lines, sells goods of the same nature as or of a similar nature to goods being sold by the first-mentioned person, without the consent of the second-mentioned person.

Removal and impoundment

14. (1) For the purpose of this article goods also means any holder, vehicle or movable structure.
- (2) An officer may remove and impound any goods—
- (a) which he reasonably suspects is being used or intended to be used or has been used in or in connection with street trading, vending or hawking;
 - (b) which he finds at a place where street trading is restricted or prohibited in terms of section 4 to 12 inclusive and which, in his opinion, constituted an infringement of any such section.
- (3) The disposal of any goods, article, receptacle, vehicle or structure removed and impounded as contemplated in subsection (1), and the liability of any person for the expenses incurred in connection with such removal, impoundment or disposal, shall be in accordance with the regulations prescribed by the Administrator under section 6 (1) (b) of the Act.
- (4) Any officer acting in terms of subarticle (2) has to—
- (a) issue a receipt to the person conducting the business of street trading, vending or hawking, in terms of any goods thus removed or impounded; and
 - (b) without delay turn in such goods at the local authority in which area of jurisdiction such goods were found.

Presumptions

15. (1) In any prosecution for an offence under these by-laws, an allegation in the charge concerned that—
- (a) any goods with which a business was carried on were or were not of a particular kind, class, type or description;
 - (b) any goods were sold or offered for sale;
 - (c) any place was situated in a public road or public place or within a particular area;
 - (d) any person carried on the business of street trading and in a manner and place alleged, shall be presumed to be correct unless the contrary is proved.
- (2) In any criminal proceedings for a contravention of these by-laws, where it is shown that—
- (a) any goods were displayed in a public road or public place, such goods shall be presumed to have been offered for sale;
 - (b) any property used in the provision of any services was available in a public road or public place, such services shall be deemed to have been offered for supply.

Vicarious responsibility of persons carrying on business

16. When an employee of a person conducting the business of street trading does or omits to do any act which would be an offence in terms of these by-laws for that person to do or omit to do, that person shall be deemed himself to have done or omitted to do the act, unless he satisfies the court that—

- (a) he neither connived at or permitted the act or omission by the employee concerned;
- (b) he took all reasonable steps to prevent the act or omission; and
- (c) an act or omission, whether lawful, of the nature charged on no condition or under no circumstance fell within the scope of the authority or employment of the employee concerned, and the fact that the said person issued instructions whereby an act or omission of that nature is prohibited, shall not in itself be sufficient proof that he took all reasonable steps to prevent the act or omission.

Vicarious responsibility of employees

17. When a person carrying on the business of street trading is by virtue of section 16 liable for an act or omission by an employee of that person, that employee shall also be liable therefor as if he were the person carrying on the business concerned.

Offences and penalties

18. Any person who—

- (a) contravenes any of the provisions of the by-laws or neglect to adhere to any conditions stated; or
- (b) threatens, resists, bothers or impedes any official or employee of the council in the execution of his or her duties or work in accordance or in virtue of these by-laws; or
- (c) with intention mislead or give false information to an official or employee of the council, is guilty of an offence and is punishable when convicted with a fine of not more than one thousand rand (R1 000,00) or confinement for not more than three (3) months or both.

BESIGHEID VAN STRAATHANDELAAR, VENTER OF SMOUS*****Woordomskrywing***

1. Tensy uit die samehang anders blyk, het 'n woord of 'n uitdrukking waaraan 'n betekenis in die Wet op Besighede, 1991 (Wet 71 van 1991) geheg is, dieselfde betekenis wat aldus toegewys is in hierdie verordeninge en beteken—
 - A. "beampte"—
 - (a) 'n verkeersbeampte aangestel kragtens artikel 3 van die Padverkeerswet (Wet 29 van 1989);
 - (b) 'n lid van die Mag soos omskryf in artikel 1 (1) van die Polisiewet, 1958 (Wet 7 van 1958);
 - (c) 'n vredesbeampte beoog in artikel 334 van die Strafproseswet, 1977 (Wet 51 van 1977);
 - B. "beperkte gebied" enige plek wat kragtens artikel 6A(2) (a) van die Wet verklaar is en nie in stryd met 'n voorwaarde wat deur die Raad ten opsigte van so 'n gebied opgelê is nie;
 - C. "dienste" enige stelsel deur of namens 'n plaaslike owerheid bestuur vir die versameling, afvoer, behandeling of wegdoen van vullis, rioolvuil of stormwater of vir die vervaardiging, opwekking, opvang, opberging, suiwering, distribusie, geleiding, transmissie, vervoer, voorsiening of verskaffing van water, gas of elektrisiteit;
 - D. "die Wet" die Wet op Besighede, 1991 (Wet No 71 van 1991);
 - E. "elendom" enige artikel, houer, vervoermiddel of struktuur wat gebruik word of geag gebruik te word in verband met die dryf van besigheid as straathandelaar en sluit in die goedere waarin die handelaar handel dryf;
 - F. "goedere" enige lewende hawe en enige oordraagbare belange;
 - G. "handel dryf" die verkoop van goedere of dienste op 'n openbare pad of openbare plek;
 - H. "nasionale gedenkwaardigheid" enige gebou wat kragtens die Wet op Nasionale Gedenkwaardighede, 1969 (Wet 28 van 1969) tot nasionale gedenkwaardigheid verklaar is;
 - I. "oorlas", enige gedrag wat 'n stand van sake of toestand meebring of kan meebring wat 'n bron van gevaar vir die persoon of eiendom van ander inhou of wesenslik inmeng met hul gewone gerief, gemak, rus of vrede;
 - J. "openbare geboue" enige gebou wat alleenlik deur die Staat of Raad besit en geokkupeer word;

- K. "openbare pad" enige pad, straat, deurgang of enige ander plek (hetsy 'n deurgang of nie) wat gewoonlik deur die publiek of 'n deel daarvan gebruik word of waartoe die publiek of 'n deel daarvan 'n reg van toegang het, en ook—
- (a) die soom van enige sodanige pad, straat of deurgang;
 - (b) enige brug, pont of drif waaroor of waardeur enige sodanige pad, straat of deurgang loop;
 - (c) enige ander werk of voorwerp wat 'n deel uitmaak van of verbind is met of behoort tot daardie pad, straat of deurgang;
- L. "openbare plek" enige plek soos omskryf in artikel 2 van die Ordonnansie op Plaaslike Bestuur, 1974 (Ordonnansie 20 van 1974);
- M. "Raad" die Munisipale Raad van Douglas;
- N. "rommel" enige houer of ander materiaal wat weggegooi of agtergelaat is deur die straathandelaar of sy kliënte;
- O. "soom" die gedeelte wat in artikel 1 van die Padverkeerswet, 1989 (Wet 29 van 1989) as soom gedefinieer word;
- P. "sypaadjie" die gedeelte wat in artikel 1 van die Padverkeerswet, 1989 (Wet 29 van 1989) as sypaadjie gedefinieer word;
- Q. "tuin" enige tuin of park waartoe die publiek 'n reg van toegang het;
- R. "verbode gebied" enige gebied wat verklaar is of verklaar kan word kragtens artikel 6A (2) van die Wet deur 'n besluit van die Raad om straathandelaar in die gebied te verbied;
- S. "verkoop" die verskaffing, omruiling, huur, stoor, uitstal, aanbieding of voorbereiding vir verkoop.

Vir die toepassing van die bepalings van hierdie verordening omvat 'n persoon wat die besigheid van straathandelaar, venter of smous dryf, enige werknemer van enige sodanige persoon en enige handeling uitgevoer op 'n openbare pad of openbare plek sal beskou word as die dryf van 'n straathandelaarsbesigheid.

Vryheid om handel te dryf

2. Onderworpe aan die bepalings van artikels 3 en 4 en enige ander wet wat hierby belang het, word die besigheid van straathandelaars vrylik toegelaat behalwe in die geval waar dit beperk of verbied word ingevolge artikels 5 tot 12 asook artikels 14 en 15.

Algemene gedrag

3. 'n Persoon wat die besigheid van straathandelaar, venter of smous bedryf sal—
- (a) nie sy eiendom op 'n soom of publieke plek plaas nie behalwe met die doel om handel te dryf nie;
 - (b) verseker dat sy eiendom nie 'n openbare pad of plek sal beslaan wat langer as drie meter en wyer as twee meter is nie;
 - (c) sy eiendom in so 'n posisie plaas dat dit 'n gevaar vir die publiek inhou of enige iemand kan beseer nie;
 - (d) sy eiendom so plaas dat toegang vrylik verkry kan word tot enige dienste of brandkraan;
 - (e) wanneer sy besigheid vir die dag afgehandel is, is eiendom verwyder na 'n plek anders as 'n openbare pad of plek;
 - (f) nie sy goedere ten toon stel voor 'n gebou of ander private grond sonder die toestemming van sodanige eienaar, huurder of die persoon in beheer van sodanige gebou of grond nie;
 - (g) op versoek van 'n werknemer of agent van die Raad of enige ander verskaffer van telekommunikasie of elektrisiteit of enige ander dienste, sy eiendom so verskuif om werk of onderhoud wat in verband met enige openbare pad, plek of enige ander dienste staan, toe te laat;
 - (h) nie enige voorwerp vasmaak, van watter aard ook al en deur watter manier ook al, aan enige gebou, struktuur, sypaadjie, boom, parkeermeter, lamppaal, elektrisiteitspaal, telefoonhokkie, posbus, verkeersteken, bank of enige ander openbare toerusting in of op 'n openbare pad of plek nie;
 - (i) nie 'n vuur maak op 'n plek of in sodanige omstandighede wat enige gevaar skep vir enige iemand of gebou of voertuig of enige ander openbare toerusting nie;
 - (j) nie sy eiendom in 'n mangat of stormwaterdrein stoor nie;
 - (k) nie by die plek van sodanige besigheid oornag nie;
 - (l) nie enige struktuur (uitgesonderd 'n toestel wat op dieselfde wyse werk as en die vorm het van 'n sambreel) met die doel om skuiling te verskaf oprig sonder die voorafverkreë skriftelike toestemming van die Raad nie.

Sindelikheid van plek van besigheid en beskerming van openbare gesondheid

4. Elke persoon wat die besigheid van straathandelaar, venter of smous dryf, sal—
- (a) die area wat deur hom gebruik word vir besigheid in 'n skoon en higiëniese toestand hou;
 - (b) sy eiendom in 'n skoon en higiëniese toestand hou;

- (c) behoorlik van alle rommel gegenereer deur sy besigheid effektief ontslae raak deur gebruik te maak van vullishouers wat voorsien is deur die Raad;
- (d) nie van rommel ontslae raak deur dit in mangate, stormwaterdreine of ander plekke wat nie vir vullisstorting geoormerk is, te stort nie;
- (e) sy area wat gebruik was vir besigheid na afloop van elke dag skoon en in 'n higiëniese toestand agterlaat;
- (f) in die geval waar voedselvoorberei word alle stappe neem as wat nodig mag wees om die storting van enige vet of olie in 'n openbare pad of plek te voorkom, asook enige reuk of rook wat mag ontstaan so te beheer dat die nie 'n oorlas veroorsaak nie;
- (g) op versoek van enige werknemer of agent van die Raad sy eiendom verskuif om die skoonmaak van die area te bewerkstellig;
- (h) sy besigheid op so 'n manier bedryf dat dit nie 'n bedreiging vir die openbare gesondheid of veiligheid is nie.

Obstruksie van voetgangers

5. Geen persoon sal besigheid doen waar—

- (a) dit toegang tot enige openbare toerusting soos 'n bushalte of -hokkie, toustanery, vullishouer of ander fasiliteite verhinder nie;
- (b) die uitsig van winkelvesters belemmer en die persoon in beheer van sodanige winkel beswaar daarteen maak nie;
- (c) die toegang tot 'n ingang of uitgang van 'n besigheid of outomatiese bankteller verhinder nie;
- (d) die toegang tot 'n voetgangerskruising belemmer nie;
- (e) die toegang tot enige voertuig belemmer nie;
- (f) minder as 'n halwe meter in wydte op 'n sypaadjie ooplos vir voetgangersgebruik nie;
- (g) dit op enige ander manier 'n hindernis vir voetgangers veroorsaak.

Obstruksie van voertuigverkeer

6. Geen persoon sal besigheid doen waar dit—

- (a) 'n obstruksie op 'n rybaan veroorsaak nie;
- (b) beperkte toegang tot parkeer- of laaionies of ander fasiliteite vir voertuigverkeer veroorsaak nie;
- (c) enige padverkeersteken of -merk of kennisgewing of teken wat daarmee in verband staan, verberg nie;
- (d) op enige wyse met enige voertuig, wat langs bogenoemde staan, inmeng nie.

Handel dryf beperk tot sekere ure en sekere plekke

7. Geen persoon sal handeldryf—

- (a) op 'n soom aangrensend aan enige plek van aanbidding, nasionale monument of openbare gebou nie; of
- (b) buiten die gebied wat gespesifiseer is in Bylae A en buite die ure wat teenoor die gebied aangedui is nie.

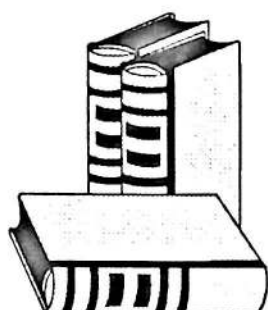
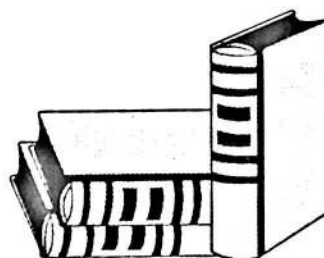
