NOTICE 33 OF 1999

THE PREMIER HAS APPROVED THE FOLLOWING BY-LAW FRAMED BY THE MUNICIPAL COUNCIL OF HOPETOWN
BY-LAW RELATING TO THE PREVENTION AND SUPPRESSION OF NUISANCES

Definition

1. In this by-law—

“**Council**” means the Municipal Council of Hopetown

“**noise nuisance**” means any sound which disturbs or impairs or may disturb or impair the convenience of peace of any person;

“**public peace of security**” means public tranquillity, calmness, safety and freedom from civil disorder;

“**public place**” means and includes any public street of place, any public conveyance, any place of public entertainment, any place of public gathering or any place which is open to public view; and

“**public street**” means any street, road or highway, thoroughfare, lane, footpath, sidewalk, alley, passage square, bridge or any other place of a like nature or any portion thereof, and include any appurtenance thereto.

2. Disturbance of the peace

1. No person shall make, produce or cause a disturbing noise, or allow it to be made, produced or caused by any person, animal, machine, device or apparatus or any combination thereof whether in a public or on private property.

2. No person shall—

(a) operate or lay, or allow to be operated or played, a radio, television set, drums, musical instrument, sound amplifier, loudspeaker system or similar device producing, reproducing or amplifying sound so as to cause a noise nuisance;

(b) offer any article for sale by means of any megaphone, loudspeakers or other similar device, or by shouting, ringing a bell or making other sound or by allowing shouting, the ringing of a bell or the making of other sound in a manner which may cause a noise nuisance;

(c) except in an emergency, emits a sound, or allow a sound to be emitted by means of a bell, carillon, siren, hooter, static alarm, whistle, loudspeaker or similar device if it may cause a noise nuisance;

(d) drive a vehicle on a public street in such a manner that it may cause a noise nuisance;

3. No person shall at any time of the day or night disturb the public peace and security in any public place in Hopetown by wrangling, quarrelling, fighting or challenging to fight, or by striking with or brandishing or using in a threatening manner any stick or other weapon, or by any riotous, violent or unseemly behaviour, which constitutes or may disturbance of the public peace and security.

4. No person shall in any public in Hopetown use any abusive or threatening language or commit any act which is liable or calculated to cause a breach of the peace.

5. If a noise emanating from a building, premises, vehicle, recreational vehicle or street is a disturbing noise or noise nuisance the person causing such noise or who is responsible therefore, or the owner or occupant of such building, premises, vehicle or recreational vehicle from which or from where such noise emanates or may emanate, or all such persons is deemed responsible for the disturbing noise or noise nuisance and punishable in terms of this by-law.

3. Animals

1. No person shall allow an animal owned or controlled by him or her to cause a noise nuisance.

2. No person shall permit any animal, of which he/she is the owner or in charge of, to rush to pedestrians, motor-cars or cyclists, or permit such animal to interfere with the comfort or safety of the public.

3. No person shall keep on any premises in Hopetown any wild, ferocious or dangerous animal unless such animal is securely tied up or confined.

4. The council may, subject to the application penalty of this by-law, impound or cause to be impounded such animal, if the owner or person in charge of an animal fails to comply with an instruction referred to.

4. Penalty

Any person contravening any provision of this by-law shall be guilty of an offence and liable on conviction to a penalty not exceeding R200,00 and in the event of a second or further offence, to a further penalty not exceeding R500,00.

VERORDENING INSAKE DIE VOORKOMING EN ONDERDRUKKING VAN OORLASTE

Woordomskrywing

1. In hierdie verordening beteken—

“**dier**” ook voëls en pluimvee;

“**geraasoorlas**” enige klank wat die gerief of rus van iemand versteur of aantas of kan versteur of aantas;

"openbare plek" 'n openbare straat of plek, 'n openbare vervoermiddel, 'n openbare vermaaklikheidsplek, 'n plek van openbare samekoms, of 'n plek in die openbare gesig;

"openbare rus en vrede" publieke kalmte, sekerheid, vreedzaamheid en vryheid van openbare wanorde;

"openbare straat" enige straat, pad of grootpad, verkeersweg, deurgang, voetpad, syaadjie, steeg, gang, plein, brug of enige ander plek van 'n dergelike aard of enige gedeelte daarvan en omvat dit enigiets wat daarby behoort; en

"Raad" die Munisipale Raad van Hopetown.

2. Verstoring van rus

1. Niemand mag 'n steurende geraas maak, voortbring of veroorsaak of toelaat dat dit gemaak, voortgebring of veroorsaak word, deur enige persoon, dier, masjien, toestel of apparaat of enige kombinasie daarvan nie, hetsy op 'n openbare plek of 'n private perseel.

2. Niemand mag—

(a) 'n radio, televisiestel, tamboer, musiekinstrument, klankversterker, luidsprekerstelsel of soortgelyke toestel wat klank produseer, reproduseer of versterk, bedryf of bespeel of toelaat dat die bedryf of bespeel word sodat dit 'n geraasoorlas kan veroorsaak nie;

(b) 'n artikel te koop aanbied deur middel van 'n megafoon, luidspreker of dergelike toestel of deur te skreeu, 'n klok te lui of ander geluide voort te bring of deur toe te laat dat geskreeu, 'n klok gelui ander geluide voortgebring word op 'n wyse wat 'n geraasoorlas kan veroorsaak nie;

(c) behalwe 'n noodgeval, 'n geluid vrystel, of toelaat dat 'n geluid vrygestel word, deur middel van 'n klokkespel, sirene, toeter, statiese alarm, fluit, luidspreker of soortgelyke toestel, indien dit 'n geraasoorlas kan veroorsaak nie;

(d) 'n voertuig op 'n openbare straat op so 'n wyse bestuur dat dit 'n geraasoorlas kan veroorsaak nie;

3. Niemand mag te eniger tyd gedurende die dag of nag die openbare rus en vrede in 'n openbare plek te Hopetown versteur deur te twis, rusie te maak, 'n bakleiery of uitdaging tot bakleiery, of deur met 'n stok of ander wapen te slaan of dit te swaai of op 'n dreigende wyse te gebruik of deur enige ander oproerige, gewelddadige of onbetaamlike gedrag wat 'n versteuring van die openbare rus en vrede daarstel of 'n versteuring van die openbare rus en vrede kan daarstel nie.

4. Niemand mag in enige openbare plek te Hopetown beledigende of dreigende taal besig of iets doen wat waarskynlik die vrede sal versteur of wat daarop bereken is om die vrede te versteur nie.

5. Indien 'n geraas wat van 'n gebou, perseel, voertuig, ontspanningsvoertuig of straat afkomstig is, 'n steurende geraas of geraasoorlas is, is die persoon wat sodanige geraas veroorsaak of wat daarvoor verantwoordelik is, of die eienaar of okkupant van sodanige gebou, perseel, woning of ontspanningsvoertuig waaruit of waarvandaan sodanige geraas afkomstig is of kan wees, of al sodanige persone geag verantwoordelik te wees vir die steurende geraasoorlas en strafbaar in terme van hierdie verordening.

3. Diere

1. Niemand mag toelaat dat 'n dier wat deur hom of haar besit of beheer word, 'n geraasoorlas veroorsaak nie of vir die omgewing 'n bron van oorlas is nie.

2. Niemand mag toelaat dat 'n dier wat aan hom/haar of onder sy/haar toesig is, op voetgangers, motors of fietsryers afstorm of toelaat dat sodanige dier die gerief of veiligheid van 'n lid van die publiek belemmer nie.

3. Niemand mag op enige perseel in Hopetown enige wrede, wilde of gevaarlike dier aanhou nie, tensy sodanige dier stewig vasgemaak of opgesluit is.

4. Die raad mag behoudens die toepaslike strafbepaling van hierdie verordening, ook so 'n dier skut of laat skut indien eienaar of persoon in beheer van 'n dier versuim om aan die lasgewings hierbo vermeld, te voldoen.

4. Strafbepaling

Iedereen wat 'n bepaling van hierdie verordening oortree, is skuldig aan 'n misdryf en by skuldigbevinding strafbaar met 'n boete van hoogstens R200,00 en in die geval van 'n tweede of verdere misdryf, met 'n verdere boete van hoogstens R500,00.
