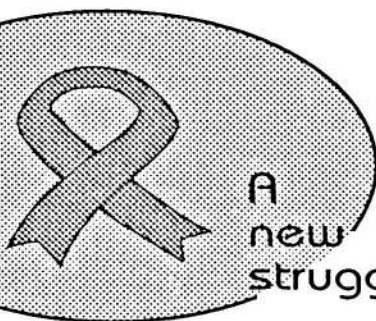

The Executive Council of the Northern Cape Province hereby gives notice of its decision to rescind the undermentioned 45 km radius exclusivity clause from the Policy Directives for Gambling and related matters in the Northern Cape Province, published in *Provincial Gazette* No. 264, which provides that;

"In the case of the allocation of a casino licence, no other casino licence or limited gambling machine licence will be allocated within a 45 km range from the Municipal Offices of Kimberley, Upington and Coleberg".
