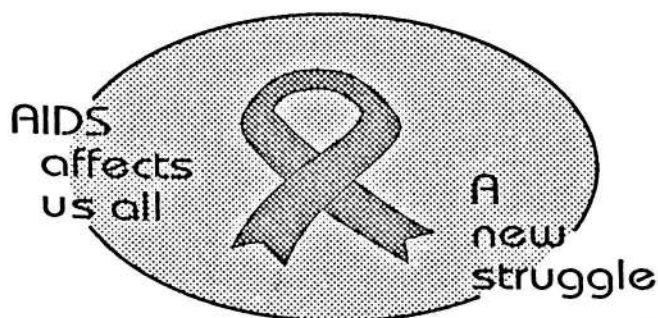

BO-KAROO DISTRICT COUNCIL: CLOSURE OF A PORTION OF DIVISIONAL ROAD 2451

Under section 3 of the Roads Ordinance, 1976
(Ordinance No. 19 of 1976)—

1. I hereby declare that the portion of about 17,93 km of Divisional Road 2451 described in the Schedule and situated within the Bo-Karoo District Council Area, the location and route of which are as indicated by means of an unbroken green line marked A-B on plan RL(P)12/2000, which is filed in the offices of the Chief Director, Department of Transport, 22 Fabricia Road, Kimberley and the Bo-Karoo District Council, De Aar has been closed.

2. I hereby publish for general information that the number on the plan is RL(P)12/2000, and not plan 1/2000 as mentioned in the advertisement of the proposed closure as published in Die Echo on 30 June 2000. Take further notice that the wording in the Schedule differs slightly from that in the advertisement, but it remains the same portion of Divisional Road 2451 that is being closed.
