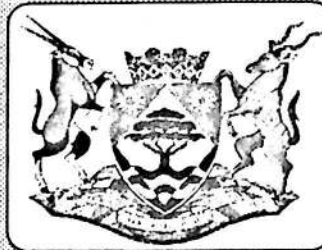

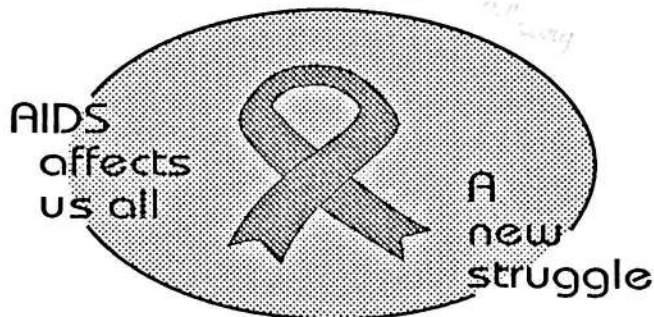

Northern Cape Province

No. 10, 2001

BO-KAROO DISTRICT MUNICIPALITY: CLOSURE OF DIVISIONAL ROAD 3011, AND PROCLAMATION OF A MINOR ROAD

Under sections 3 and 4 of the Roads Ordinance, 1976 (Ordinance No. 19 of 1976), and section 7 of the Advertising on Roads and Ribbon Development Act, 1940 (Act No. 21 of 1940):

- (1) I hereby declare that Divisional Road 3011, described in Schedule 1, situated within the Bo-Karoo District Municipality area, the location and route of which are indicated by means of an unbroken green line marked ABC on plan RL(P)16/98, which is filed in the offices of the Head of Department, Department of Transport Roads and Works, 22 Fabricia Road, Kimberley and the offices of the Bo-Karoo District Municipality, shall be closed;
- (2) I hereby declare that the road described in schedule 2, situated within the Bo-Karoo District Municipality area, the location and route of which are indicated by means of a broken blue line marked AB on plan RL(P)16/98, which is filed in the offices of the Head of Department, Department of Transport Roads and Works, 22 Fabricia Road, Kimberley and the offices of the Bo-Karoo District Municipality shall be a public road with Minor Road status;
- (3) I hereby withdraw Proclamation 318 of 1979, dated 9 November 1979, in so far as it applies to the proclamation as building restriction road, of the road described in Schedule 1 and marked AC on Plan RL(P)16/98.
