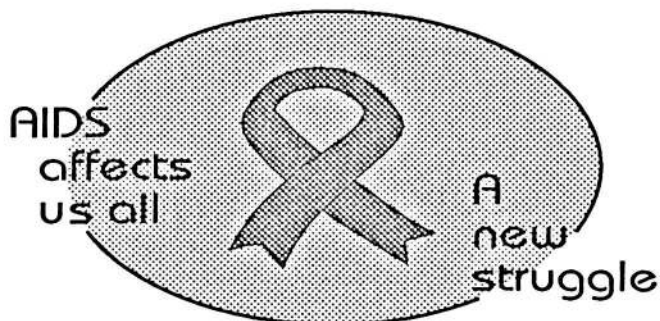

#### BO-KAROO DISTRICT MUNICIPALITY: CLOSURE OF MINOR ROAD 18D

Under section 3 of the Roads Ordinance, 1976 (ordinance No. 19 of 1976), I hereby declare that Minor Road 18D, situated within the Bo-Karoo District Municipality area, the location and route of which are indicated by means of an unbroken blue line marked AB on Plan RL(P)4/98, which is filed in the offices of the Head of Department, Department of Transport Roads and Works, 22 Fabrica Road, Kimberley and the offices of the Bo-Karoo District Municipality: shall be closed as described in the Schedule.
