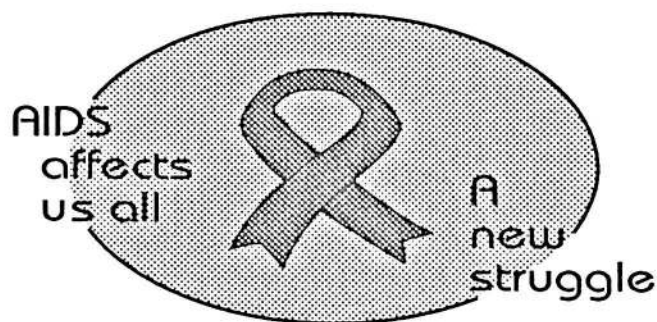

OFFICIAL NOTICE 31 OF 2001

DEPARTMENT OF EDUCATION: NORTHERN CAPE PROVINCE

FURTHER EDUCATION AND TRAINING ACT, 1998

NOTICE TO INTERESTED PERSONS REGARDING:

- ☐ THE INTENTION TO DECLARE TECHNICAL COLLEGES IN THE NORTHERN CAPE PROVINCE AS PUBLIC FURTHER EDUCATION AND TRAINING INSTITUTIONS AND FURTHER;
- ☐ DETERMINATION OF A SINGLE COUNCIL FOR MORE THAN ONE DECLARED INSTITUTION;
- ☐ THE MERGER OF SPECIFIC DECLARED FURTHER EDUCATION AND TRAINING INSTITUTIONS INTO MERGED FURTHER EDUCATION AND TRAINING INSTITUTIONS

I, Tina Monica Joemat-Pettersson, Member of the Executive Council for the Northern Cape Province, hereby give notice in terms of section 4 of the Further Education and Training Act, 1998 (Act No. 98 of 1998), of my intention—

(a) to declare the following as Further Education and Training Institutions:

- Northern Cape Technical College as Northern Cape Further Education and Training College;
- Kimberley Technical College as Kimberley Further Education and Training College;
- Kathu Technical College as Kathu Further Education and Training College;
- Upington Technical College as Upington Further Education and Training College;
- Namaqualand Technical Training Institute as Namaqualand Further Education and Training College;
- De Aar Campus as De Aar Further Education and Training College.

It is my intention to make my decision regarding the said declaration of these institutions as further education and training institutions not later than 11 September 2001.

(b) to determine that I deem it in the best interest of education and the institutions concerned that the governance of the following cluster of institutions shall be vested in single councils once they are declared as Further Education and Training Institutions as contemplated in paragraph (a) above.

Take notice further that a single council contemplated in paragraph (b) hereabove shall be appointed in accordance with a notice of composition for such council to be published in the *Provincial Gazette* not later than 1 September 2001.

Further take notice that a single council referred to in paragraph (b) hereabove shall be appointed for each of the following cluster of declared institutions:

- (i) Upington Further Education and Training College; Kathu Further Education and Training College; Namaqualand Further Education and Training College and De Aar Further Education and Training College.
 - (ii) Northern Cape Further Education and Training College and Kimberley Further Education and Training College.
- (c) to merge the clusters of declared Further Education and Training Institutions concerned as contemplated in paragraph (b) (i) and (b) (ii), into two Further Education and Training Institutions for the Northern Cape Province. I intend to make my decision to merge these institutions not later than 1 January 2002. The Councils of the merged institutions will be appointed in accordance with the notice of composition for the merged institutions as contemplated in section 8 (4) of the Further Education and Training Act, 1998 (No. 98 of 1998), which will be published in the *Provincial Gazette* not later than 1 January 2002.

In the Notice of Declaration as contemplated in paragraph (a), I will give further opportunity for comment concerning the merger of these institutions.

Ek, Tina Monica Joemat-Pettersson, Lid van die Uitvoerende Raad van die Provinsie, gee hiermee kennis ingevolge Artikel 4 van die Wet op Verdere Onderwys en Opleiding, 1998 (Wet No. 98 van 1998) van my voorneme—

(a) Om die volgende as Verdere Onderwys en Opleidingsinstellings te verklaar:

- Noord-Kaap Tegniese Kollege as Noord-Kaap Verdere Onderwys en Opleidingskollege;
- Kimberley Tegniese Kollege as Kimberley Verdere Onderwys en Opleidingskollege;
- Kathu Tegniese Kollege as Kathu Verdere Onderwys en Opleidingskollege;
- Upington Tegniese Kollege as Upington Verdere Onderwys en Opleidingskollege;
- Namaqualand Tegniese Opleidingsinstituut as Namaqualand Verdere Onderwys en Opleidingskollege;
- De Aar Kampus as De Aar Verdere Onderwys en Opleidingskollege.

Ek is van voorneme om my besluit om hierdie instellings as verdere onderwys- en opleidingsinstellings te verklaar nie later as 11 September 2001 bekend te maak nie.

(b) Om te bepaal dat ek dit in die beste belang van onderwys en die betrokke instellings beskou dat die beheer van die volgende groepering van instellings deur 'n enkele raad behartig sal word nadat hulle tot Verdere Onderwys en Opleidingsinstellings verklaar is soos beoog in paragraaf (a) hierbo.

'n Enkele raad sal aangewys word in ooreenstemming met die kennisgewing van samestelling van sodanige raad wat in die *Provinsiale Koerant* gepubliseer sal word nie later as 1 September 2001.

'n Enkele raad sal aangestel word vir elk van die volgende groeperings van verklaarde inrigtings:

- (i) Upington Verdere Onderwys en Opleidingskollege; Kathu Verdere Onderwys en Opleidingskollege; Namaqualand Verdere Onderwys en Opleidingskollege en De Aar Verdere Onderwys en Opleidingskollege.
- (ii) Noord-Kaap Verdere Onderwys en Opleidingskollege en Kimberley Verdere Onderwys en Opleidingskollege.

- (c) Om die betrokke groeperinge van verklaarde Verdere Onderwys- en Opleidingsinstellings soos beoog in paragraaf (b) (i) en (b) (ii) in twee Verdere Onderwys en Opleidingsinstellings vir die Noord-Kaap saam te smelt. Ek is van voorneme om my besluit om hierdie instellings saam te smelt nie later as 1 Januarie 2002 te neem nie. Die Rade van die saamgesmelte instellings sal aangestel word in ooreenstemming met die kennisgewing van die samestelling van die saamgesmelte instellings soos beoog in afdeling 8 (4) van die Verdere Onderwys en Opleidingswet, 1998 (No. 98 van 1998) en wat in die *Provinsiale Koerant* gepubliseer sal word nie later as 1 Januarie 2002.

In die kennisgewing van verklaring soos beoog in paragraaf (a) sal ek verdere geleentheid bied om insette te maak aangaande die samesmelting van hierdie instellings.
