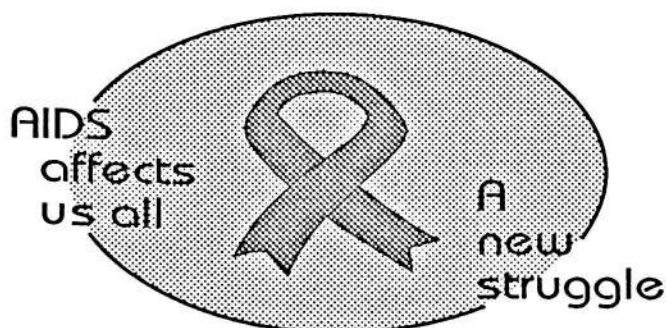

NATIONAL LAND TRANSPORT TRANSITION ACT 22 OF 2000

AMENDMENT OF PROVINCIAL LAND TRANSPORT REGULATIONS ON OPERATING LICENCES

NORTHERN CAPE PROVINCE

NORTHERN CAPE PROVINCIAL FINANCE BILL

BILL

To charge the Provincial Revenue Account with certain unauthorised expenditure and to authorise other expenditure

BE IT ENACTED by the Provincial Legislature of the Northern Cape Province as follows:

Defraying of unauthorised expenditure from the Provincial Revenue Account for financial year 1996/97

1. (1) The Provincial Revenue Account is hereby charged with the amount of R233 559,60 (two hundred and thirty three thousand, five hundred and fifty nine rand and sixty cents) to defray certain expenditure over and above the amounts appropriated for the services of the province for the financial year which ended on 31 March 1997.

(2) The expenditure referred to in subsection 1, is set forth in schedule 1 and is more fully described on pages 9 and 10 of the Report of the Auditor-General on the accounts of Provincial Administration of the Northern Cape for 1996/97 (PR 82/1998), which has been submitted to the Provincial Legislature and in the Report of the Standing Committee on Public Account, 2001.

Defraying of unauthorised expenditure from the Provincial Revenue Account for financial year 1997/98

2. (1) The Provincial Revenue Account is hereby charged with the amount of R205 917 653,11 (two hundred and five million, nine hundred and seventeen thousand, six hundred and fifty three rand and eleven cents) to defray certain expenditure over and above the amounts appropriated for the services of the province for financial year which ended on 31 March 1998.

(2) The expenditure referred to in subsection 1, is set forth in schedule 1 and is more fully described on pages 9 and 10 of the Report of the Auditor-General on the accounts of Provincial Administration of the Northern Cape for 1997/98 [PR 96/1999], which has been submitted to the Provincial Legislature and in the Report of the Standing Committee on Public Account, 2001.

Authorising of expenditure

3. (1) The expenditure of R101 007,00 incurred by the Department of Health, and more fully described on page 7 paragraph 5 of the Report of the Auditor-General on the Accounts of the Provincial Administration of the Northern Cape for 1995/96 [PR39/1997], which has been submitted to the Provincial Legislature and in the Report of the Standing Committee on Public Account, 2001, is hereby authorised.

(2) The expenditure of R161 581,52 incurred by the Department of Education, and more fully described on page 10 paragraph 11 (2) of the Report of the Auditor-General on the Accounts of the Provincial Administration of the Northern Cape for 1995/96 [PR39/1997], which has been submitted to the Provincial Legislature and in the Report of the Standing Committee on Public Account 2001, is hereby authorised.

Short Title

4. This Act shall be called the Northern Cape Provincial Finance Act, 2001, and takes effect on a date determined by the Premier by Proclamation.
