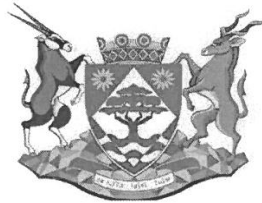

BY LEGISLATION FROM ONE TO ANOTHER MEMBER OF THE EXECUTIVE  
COUNCIL IN TERMS OF SECTION 137 OF THE CONSTITUTION**

In terms of section 137 of the Constitution of the Republic of South Africa, 1996, I hereby transfer the administration of and powers and functions entrusted by-

- (a) Chapter 5 of the Children's Act, 2005 (Act No. 38 of 2005) ("the Children's Act"), in respect of only partial care facilities that provide early childhood development services as defined in section 91(2) and early childhood development programmes as defined in section 91(3) of the Children's Act to the extent that they provide such programme or service;
- (b) Chapter 6 of the Children's Act; and
- (c) Chapters 20 and 21 of the Children's Act only in respect of the powers transferred in paragraphs (a) and (b);

in so far as they relate to the MEC of Social Development, from such MEC to the MEC of Basic Education, with effect from 01 April 2022.



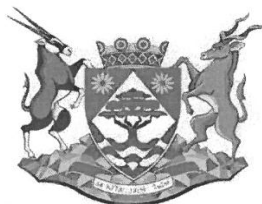



- (a) Hoofstuk 5 van die "Children's Act, 2005" (Wet No. 38 van 2005) ("die Kinderwet"), slegs ten opsigte van deelsorgfasiliteite wat vroeëkinderonwikkelingsdienste en -programme verskaf soos omskryf in onderskeidelik artikel 91(2) en 91(3) van die Kinderwet, in die mate waarin hulle daardie dienste en programme verskaf;
- (b) Hoofstuk 6 van die Kinderwet; en
- (c) Hoofstuk 20 en 21 van die Kinderwet, slegs ten opsigte van die bevoegdhede oorgedra in paragraaf (a) en (b),

in sover dit betrekking het op die Lid van die Uitvoerende Raad (LUR) vir Maatskaplike Ontwikkeling, van daardie LUR oor aan die LUR vir Basiese Onderwys, met ingang van 1 April 2022.

Enige vermelding van die LUR vir Maatskaplike Ontwikkeling, in sover dit betrekking het op die bevoegdhede en funksies in Hoofstuk 5 en 6 en artikel 309 van die Kinderwet, moet uitgelê word as 'n vermelding van die LUR vir Basiese Onderwys.


