APPLICATION FOR CERTIFICATE OF SUITABILITY IN TERMS OF SECTION 78 OF THE NORTH WEST GAMBLING ACT 2001, (Act No.2 OF 2001), AS AMENDED.

Notice is hereby given in terms of the provisions of section 29 of the North West Gambling Act, 2001 (Act No. 2 of 2001), as amended ("the Act"), that the North West Gambling Board ("the Board") received an application for a Certificate of Suitability from Sun International Management Limited a company contracted to provide Management and Technical Services to Sun International (South Africa) Limited.
