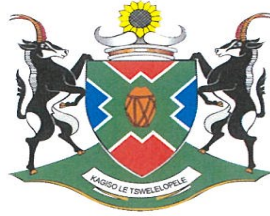

PROCLAMATION IN TERMS OF SECTION 127(2) (e) OF THE CONSTITUTION OF THE REPUBLIC OF SOUTH AFRICA, 1996 READ WITH NORTH WEST COMMISSIONS ACT ,1994 (ACT 18 OF 1994) RECONSTITUTION BAHURUTSHE BA GOPANE COMMISSION OF INQUIRY WITH THE TERMS OF REFERENCE UNDER PROCLAMATION 23 OF 2018, GAZETTE NO 7883

By virtue of the powers vested in me in terms of section 127(2)e of the constitution of the Republic of South Africa, 1996, I Patrick Dumile Nono Maloyi, in my capacity as Premier of the North West Province, hereby reconstitute the commission of inquiry established through proclamation No 23 of 2018 and published in Government Gazette Notice 7883, dated 15 May 2018, from 01 November 2023 to 28 February 2024 and further determines that the terms of reference listed in Proclamation No 23 of 2018 shall apply to the Commission of Inquiry in respect of Bahurutshe Ba Gopane.

The evidence presented before the Commission chaired by the late Mr Mangole shall for the purpose of this Commission be deemed for all intents and purposes the evidence of the reconstituted Commission under Professor Khunou.
