**B**E IT ENACTED by the Provincial Legislature of the province of Western Cape, as follows:—

**Appropriation of adjusted amounts of money for requirements of the Provincial Administration: Western Cape**

1. Subject to the provisions of the Western Cape Exchequer Law, 1994 (Law 4 of 1994), there are hereby appropriated out of the Provincial Revenue Fund for the requirements of the Provincial Administration: Western Cape in respect of the financial year ending 31 March 1997, as a charge to the Provincial Revenue Account, the adjusted amounts of money shown in Column 1 of the Schedule. 5
